**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of December 8, 2017, is made by Fifth Third Bank, as collateral agent (the "Collateral Agent") under the Security Agreements (as defined below). Capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreements.

WHEREAS, in connection with those certain Security Agreements (the Amended and Restated Security Agreement dated as of October 27, 2008 among H.I.G. Chemicals Holdings Corp. ("Holdings"), Petroferm Inc. (the "Grantor"), the other Grantors party thereto from time to time, and the Collateral Agent (the "Amended and Restated Security Agreement") and the Second Amended and Restated Security Agreement dated as of July 13, 2010 among H.I.G. Chemicals Holdings Corp. ("Holdings"), Lipo Chemicals, Inc., Vantage Oleochemicals, Inc., Vantage Specialties, Inc. and Lipo Technologies Inc. (each a "Grantor"), the other Grantors party thereto from time to time, and the Collateral Agent (the "Second Amended and Restated Security Agreement" and together with the Amended and Restated Security Agreement, the "Security Agreements")), the Grantors granted security interests (the "Security Interest Agreements") in certain intellectual property owned by the Grantors, including: (i) all trademarks and copyrights, including those listed on Annex I attached hereto (ii) all renewals and extensions of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by, each of such copyrights and trademarks; and (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Security Interest Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") and in the United States Copyright Office (the "Copyright Office") on the dates and on the reel and frame numbers or volume and document numbers set forth on Annex I hereto.

NOW THEREFORE, the Collateral Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Interest Agreements or any other agreement or document delivered in connection with the Security Agreements, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that such Collateral Agent may have in the Intellectual Property Collateral to the Grantors.

The Collateral Agent agrees, at the Grantors' expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Collateral Agent's security interest in the released collateral described herein.

THIS RELEASE, AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER SOUNDING IN CONTRACT, TORT OR OTHERWISE) BASED UPON,

ARISING OUT OF OR RELATING TO THIS RELEASE AND THE TRANSACTIONS
CONTEMPLATED HEREBY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE
WITH, THE LAW OF THE STATE OF NEW YORK WITHOUT GIVING EFFECT TO ANY CHOICE
OF LAW PRINCIPLES THAT WOULD APPLY THE LAWS OF ANOTHER JURISDICTION.
