TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

December 19, 2017

WHEREAS, each of BRAWN, LLC, a Delaware limited liability company, DOMESTICATIONS, LLC, a Delaware limited liability company, HANOVER COMPANY STORE, LLC, a Delaware limited liability company, HANOVER DIRECT MANUFACTURING, LLC, a Delaware limited liability company, SCANDIA DOWN, LLC, Delaware limited liability company, and SILHOUETTES, LLC, a Delaware limited liability company (each, a “Grantor”), had granted to WELLS FARGO BANK, NATIONAL ASSOCIATION (the “Grantee”), as agent, a security interest (the “Security Interest”) in (i) all of such Grantor’s right, title and interest in, to and under certain United States trademarks, trademark registrations and trademark applications (the “Marks”) set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising for infringement of any of the Marks or unfair competition regarding the same (all of items described in the foregoing clauses (i) through (iv), collectively, the “Collateral”), pursuant to, among other things, a certain Grant of Security Interest in United States Trademarks dated as of October 1, 2014 by and among the Grantors and the Grantee, which was filed at the United States Patent and Trademark Office on October 17, 2014 and recorded on Reel 5383, Frame 0360 (the “Grant”).


WHEREAS, the indebtedness secured by the Security Interest has been paid in full and the Grantee has agreed to terminate the Security Interest.

NOW, THEREFORE, the Grantee releases and discharges its security interest in, and reassigns to the Grantors, any and all interest in the Collateral, including, without limitation, Marks listed on Schedule A attached hereto, without recourse, representation or warranty of any kind.
