**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK  
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of December 29, 2017 ("Effective Date"), by **OBSIDIAN AGENCY SERVICES, INC.**, in its capacity as Lender and as Administrative Agent for each member of the Lender Group, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, "Grantee"), in favor of **NEWSCYCLE SOLUTIONS, INC.**, a Delaware corporation, **NEWSCYCLE SOLUTIONS AB**, a Swedish private limited liability company, and **NEWSCYCLE SOLUTIONS, INC.** (formerly known as DoApp, Inc.), a Delaware corporation (each a "Grantor" and collectively, the "Grantors").

**WHEREAS**, reference is made to that certain Credit Agreement, dated as of June 10, 2016 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among Newscycle Intermediate Holdings, LLC, a Delaware limited liability company, Newscycle Solutions, Inc., a Delaware corporation, Newscycle Sweden Holdings AB, a Swedish private limited liability company, Newscycle Solutions AB, a Swedish private limited liability company, the Lenders from time to time party thereto, and Grantee.

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of June 10, 2016, by and among Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on June 13, 2016 at Reel 5812, Frame 0243, as amended, restated, supplemented, or otherwise modified and in effect from time to time, the "Trademark Security Agreement"), the Grantors granted to Grantee a security interest in all of the Grantors' right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

**WHEREAS**, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
