The Board of Trustees (the "Board") of OCLC Online Computer Library Center, Inc. (the "Corporation"), in accordance with the Corporation's current articles of incorporation, code of regulations and applicable law, adopted by written consent the following resolutions approving an amendment to the Corporation's Amended Articles of Incorporation as attached hereto as Annex A (the "First Amendment"):

WHEREAS, the Board deems it to be advisable and in the best interests of the Corporation to change the name of the Corporation to OCLC, Inc. (the "Name Change") to better effectuate its corporate purposes; and

WHEREAS, the Board deems it advisable and in the best interests of the Corporation to (i) amend the Corporation's Amended Articles of Incorporation, in such form as attached hereto as Annex A (the "First Amendment") to effect the Name Change, (ii) amend the Corporation's Code of Regulations to reflect the Name Change, and (iii) authorize the amendment of all other instruments, internal policies, charters and similar documents to reflect the Name Change;

NOW, THEREFORE, BE IT RESOLVED, that the Name Change is hereby authorized, adopted and approved in all respects;

RESOLVED FURTHER, that the First Amendment is hereby adopted and approved in all respects;

RESOLVED FURTHER, that the Chair, Vice Chair, President & CEO, Secretary of the Corporation, or any other such officer designated by any of the foregoing in writing (each, an "Authorized Officer") be, and each of them hereby is, authorized to execute, deliver and file a Certificate of Amendment with the Secretary of State of Ohio and to pay any fees related to such filing consistent with the foregoing resolutions;

RESOLVED FURTHER, that any Authorized Officer is authorized to execute any amendment, supplement or modification to any instrument, document or agreement to which the Corporation is a party in order to reflect the Name Change, including, but not limited to, executing amendments or modifications to the Corporation's Code of Regulations, internal policies, charters and all similar documents or instruments; and

RESOLVED FINALLY, that all acts and things of any of the aforementioned Authorized Officers, which acts would have been authorized by the foregoing resolutions except that such acts were taken prior to the adoption of such resolutions, are hereby severally ratified, confirmed, approved, and adopted as acts in the name of and on behalf of the Corporation.

FIRST AMENDMENT TO  
AMENDED ARTICLES OF INCORPORATION  
OF  
OCLC Online Computer Library Center, Inc.

Pursuant to Section 1702.38 of the Ohio Revised Code, OCLC Online Computer Library Center, Inc. hereby amends its Amended Articles of Incorporation as follows:

Article FIRST is hereby amended and restated in its entirety to read as follows:

FIRST. The name of the corporation shall be OCLC, Inc. (the "Corporation").
