PROPERTY RIGHTS.

6. This Agreement shall be governed by and construed in accordance with the laws of

the State of Oklahoma, without regard to the conflict of laws rules thereof. The parties irrevocably

submit to the exclusive jurisdiction of courts located in Oklahoma County, Oklahoma for the

determination of disputes arising under or out of this Agreement.
