Assignor agrees to execute all papers and to perform such other proper acts as the Assignee may deem necessary to secure for the Assignee or its designee the rights herein assigned.

This Agreement constitutes the whole understanding, discussions and agreements by and among the Assignor and Assignee (hereinafter, collectively "the Parties"). No agreements or promises not herein expressed have been made, and the Parties acknowledge that there have been no oral, written or other agreements of any kind, unless specifically set forth herein, to induce the execution and delivery of this Agreement.
