## **TRADEMARK RELEASE**

This **TRADEMARK RELEASE** is made as of November 27, 2017 (“Effective Date”) executed by, Citizens Bank, N.A. f/k/a RBS Citizens, N.A., successor-in-interest to Citizens Bank of Massachusetts in its capacity as Lender (“Secured Party”).

**WHEREAS**, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement (the “Security Agreement”) by and among The Talaria Company, L.L.C. (the “Debtor”) and Secured Party dated May 13<sup>th</sup> 2005, the Debtor granted to Secured Party a continuing priority security interest in and to all of the Debtor’s right, title and interest in all trademarks, trademark registrations and trademark applications and any renewals thereof (collectively, the “Trademark Collateral”);

**WHEREAS**, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on May 17, 2005 at Reel 003211, Frame 0415;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, cancels and releases any and all security interests or liens it has against the Released Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and grants, assigns and conveys, without recourse or warranty, to the Debtors all of their rights, title and interest in the Released Trademarks.
