**TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST AND PATENT
SECURITY INTEREST**

THIS OMNIBUS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTERESTS AND PATENT SECURITY INTERESTS (this "Termination"), is dated as of December 29, 2017, and made by **BNP PARIBAS**, as administrative agent for certain financial institutions as lenders (in such capacity, "Administrative Agent" and "Grantee") to **CST INDUSTRIES INC.**, a Delaware corporation ("CST Industries") and **CST POWER AND CONSTRUCTION, INC.**, a California corporation ("CST Power"), together with CST Industries, the "Grantors" and each a "Grantor").

WHEREAS, pursuant to that certain Security Agreement dated as of May 23, 2012, made by Grantors in favor of Grantee (the "Security Agreement") and certain Grants of Patent Security Interests and Grants of Trademark Security Interests executed in connection therewith (the "IP Grants", together with the Security Agreement, the "Security Documents"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademark Collateral and Patent Collateral (as hereinafter defined);

WHEREAS, Grantee now desires to terminate and release the Security Documents;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

I. Definitions. The terms

(a) "Trademark Collateral" as used herein, shall mean (i) all rights, title and interest (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, indicia, tradenames, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by Grantors, or hereafter adopted and used, in its business (including, without limitation, all trademark applications and trademark registrations) (collectively, the "Trademarks"), all registrations that have been or may hereafter be issued or applied for thereon, all common law and other rights (but in no event any of the obligations) in and to the Trademarks, and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith; and (ii) all proceeds, products, rents and profits of or from any and all of the foregoing Trademark and, to the extent not otherwise included, all payments under insurance, if any (whether or not Grantees are the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark. The Trademark Collateral shall include all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademark Collateral listed on Schedule A hereto.

(b) "Patent Collateral" as used herein, shall mean (i) all rights, title and interest (including rights acquired pursuant to a license or otherwise) in and to all patents and patent applications and rights and interests in patents and patent applications under any domestic or foreign law that are presently, or in the future may be, owned or held by Grantors and all patents and patent applications and rights, title and interests in patents and patent applications that are presently, or in the future may be, owned by Grantors in whole or in part, all rights (but not obligations) corresponding thereto to sue for past, present and future infringements and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, the "Patents"); and (ii) all proceeds, products, rents and profits of or from any and all of the foregoing Patents and, to the extent not otherwise included, all payments under insurance, if any (whether or not Grantees are the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Patents. The Patent

Collateral shall include all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Patent Collateral listed on Schedule B hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Documents and terminates, releases and discharges its security interest in the Trademark Collateral and Patent Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantees in the Trademark Collateral and Patent Collateral.


