ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS

This **ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS** (this “**Assignment**”), dated as of September 20, 2017, is by **GENERAL ELECTRIC COMPANY** (individually, “**GE Company**”), as successor in interest by merger to General Electric Capital Corporation, acting in its capacity as the current and resigning administrative agent (in such capacity, the “**Retiring Agent**”) and **ARES CAPITAL CORPORATION** (individually, “**Ares**”), acting in its capacity as the successor administrative agent (in such capacity, the “**Successor Agent**”).

RECITALS:

WHEREAS, INTERMEDIX CORPORATION, a Delaware corporation, **ADVANCED DATA PROCESSING, INC.**, a Delaware corporation, **INTERMEDIX TECHNOLOGIES, INC.**, a Delaware corporation, **MEDICAL CONSULTANTS, INC.**, an Oklahoma corporation, **EMSYSTEMS, LLC**, a Delaware limited liability company, **REVENUE RESCUE, INC.**, a Delaware corporation, **INTERMEDIX ARM, LLC**, a Delaware limited liability company, **ESI ACQUISITION, INC.**, a Delaware corporation, and **INTERMEDIX OFFICE BASED, LLC**, a Delaware limited liability company, as “Grantors”, and Retiring Agent are parties to those certain intellectual property security agreements identified in Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, amended and restated, supplemented or otherwise modified from time to time, collectively, the “**Agreements**”), covering certain intellectual property set forth on Exhibit B attached hereto; and

WHEREAS, pursuant to that certain Agency Resignation and Appointment Agreement, dated as of the date hereof, by and among GE Company, as the Retiring Agent, and Ares, as the Successor Agent, Retiring Agent has assigned to the Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreements, in each instance, in its capacity as administrative agent and, if applicable, collateral agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. The Retiring Agent hereby assigns and transfers to the Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreements, and authorizes the recordation of this Assignment with the United States Patent and Trademark Office.
2. Counterparts. This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.
3. Governing Law. This Assignment and the rights and obligations of the parties under this Assignment shall be governed by, and construed, enforced and interpreted in accordance with, the laws of the State of New York.



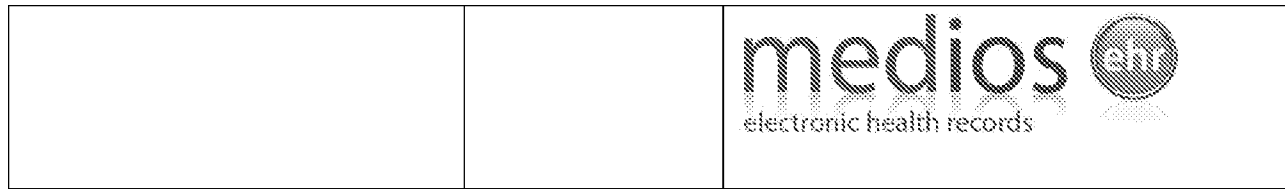
