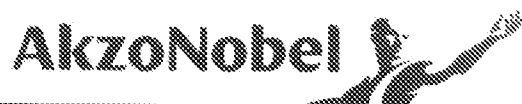

DEED OF ASSIGNMENT

(together, "the Parties")

It is hereby agreed as follows:

The Assignor is the registered owner of the Trademarks set out in Schedule A attached hereto.

The Assignor and Assignee are both group companies of the Akzo Nobel N.V. group of companies.

In consideration for EUR 1.00, (receipt of which the Assignor expressly acknowledges) the Assignor hereby enters into this Deed of Assignment, to assign to the Assignee, absolutely and with full title guarantee all of its rights, title and interest in and to the intellectual property rights of the Trademarks shown in Schedule A with effect from the date the last party executes this Deed of Assignment, including:

- (a) the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Patents, Registered Designs and Trade Marks;
- (b) all goodwill attaching to the Trade Marks and in respect of the business relating to the goods or services for which the Trade Marks are registered or used; and
- (c) the right to bring, make, oppose, defend or appeal proceedings, claims or actions, and obtain relief and to retain any damages recovered, in respect of any infringement, or any other cause of action arising from ownership, of any of the Assigned Rights, whether occurring before, on, or after the date of this Deed of Assignment.

This Deed of Assignment constitutes the entire agreement between the parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.

Each party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently) Each party agrees that it shall have no claim for innocent or negligent misrepresentation based on any statement in this Deed of Assignment.

No variation of this Deed of Assignment shall be effective unless it is in writing and signed by the parties (or their authorised representatives).


This Deed of Assignment and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.






