This IP pledge agreement (the **Agreement**) is made as of the date hereof, by and between:

- (a) **Arduino AG**, a company incorporated and organized under the laws of Switzerland, registered with the Commercial Register of the Canton of Ticino under registration number CHE-333.913.908, with registered office at Corso San Gottardo 6A, 6830 Chiasso, as pledgor (the **Pledgor**); and
- (b) **ARM Limited**, a company incorporated and organized under the laws of England & Wales, registered under registration number 02557590, with registered office at 110 Fulbourn Road, Cambridge, Cambridgeshire, CB1 9NJ as pledgee (the **Pledgee**, and together with the Pledgor, the **Parties**, and each individually a **Party**).

Whereas

- A. As of July 17, 2017, BCMI Industries SA (the **Company**) entered into an investment agreement (the **Investment Agreement**), between itself, the Existing Shareholders (as defined below) and ARM Limited, whereby ARM Limited has agreed to lend the Advance (as defined therein) to the Company for the purposes of funding the exercise of the Arduino Call Option (as defined therein).
- B. In order to satisfy certain conditions subsequent of the Investment Agreement and in order to provide security for the Pledgee, the Pledgor wishes to pledge as security for the Secured Obligations (as defined below) its Intellectual Property Rights (as defined below).

Now, therefore, the Parties hereto agree as follows:

1. Definitions and References

1.1 Definitions

Unless defined otherwise herein and except to the extent that the context requires otherwise, capitalized terms used in this Agreement shall have the meanings assigned to them in the Investment Agreement, including in particular in clause 1.3 of the Investment Agreement, which shall apply as if set out in full again here, with references to "this Agreement" being construed as references to this Agreement and with such other changes as are appropriate to fit this context.

Agreement means this IP pledge agreement.

Business Day means a Business Day as defined in the Investment Agreement, provided that in case of a day not being a Saturday or Sunday in Switzerland, Business Day shall only include any such day commercial banks in Zurich are open for normal business transactions.

Clause means any clause of this Agreement.

CO means the Swiss Code of Obligations (*Schweizerisches Obligationenrecht, OR*) of March 30, 1911, as amended from time to time (*SR 220*).

DEBA means the Swiss Federal Debt Enforcement and Bankruptcy Act (*Bundesgesetz über Schuldbetreibung und Konkurs, SchKG*) of April 11, 1889, as amended from time to time (*SR 281.1*).

Event of Default has the meaning set forth in clause 10.1 of the Investment Agreement.

Existing Shareholders has the meaning set forth in the Investment Agreement.

Group has the meaning set forth in the Investment Agreement.

Intellectual Property Rights means all intellectual property rights and claims represented by the registrations and applications of the respective intellectual property rights, in particular, patents and trademark applications and registrations, owned by the Pledgor as of the date of this Agreement (such as presently owned intellectual property rights as listed in the Intellectual Property Rights List) or thereafter, to the extent such rights are assignable (by statutory law), including any and all (by statutory law) assignable rights and benefits relating thereto, including privileges and ancillary rights in respect thereof and any interest accruing thereon as well as any right to receive the proceeds of any insurance, indemnity, warranty or guarantee relating thereto.

Intellectual Property Rights List means (i) the list of the Intellectual Property Rights provided by the Pledgor pursuant to Clause 4(e) at the date of this Agreement and as listed in [Annex 1](#) and (ii) thereafter such updated list of Intellectual Property Rights as provided by the Pledgor pursuant to the terms of this Agreement.

Investment Agreement has the meaning set forth in Whereas Clause A.

Parties or **Party** has the meaning set forth in the introductory paragraph of this Agreement.

Pledge has the meaning set forth in Clause 2.1.

Pledgee has the meaning set forth in the introductory paragraph of this Agreement.

Pledgor has the meaning set forth in the introductory paragraph of this Agreement.

Secured Obligations has the meaning set forth in Clause 2.2.

Security Document has the meaning set forth in the Investment Agreement.

Swiss Withholding Tax means any taxes imposed under the Swiss Withholding Tax Act.

Swiss Withholding Tax Act means the Swiss Federal Act on the Withholding Tax (*Bundesgesetz über die Verrechnungssteuer*) of October 13, 1965, as amended from time to time

(SR 642.21), together with the related ordinances, regulations and guidelines, all as amended and applicable from time to time.

1.2 References

References to any agreement or document shall be construed as references to such agreements or documents as amended, novated, supplemented, extended, replaced or restated from time to time, regardless of how fundamental such amendment, novation or restatement may be (even if it involves increased, new, additional, extended and/or replacement facilities or an increase in any other amount or rate).

2. Pledge of Intellectual Property Rights

2.1 Object of Pledge

- (a) The Pledgor hereby agrees to pledge and hereby unconditionally pledges the Intellectual Property Rights to the Pledgee as a first ranking continuing pledge (the **Pledge**), effective as of the date hereof, as security for the Secured Obligations.
- (b) The Pledgee hereby accepts the Pledge.

2.2 Secured Obligations

The Pledge shall serve as a first ranking and continuing security for the prompt and complete payment, discharge and performance of any and all monies from time to time due or owing, and all obligations and other actual or contingent liabilities from time to time incurred, by the Company or the Pledgor to the Pledgee under the Investment Agreement or any Security Document, as amended from time to time, in whatever currency, including, to the extent arising out of or in connection with the Investment Agreement or any Security Document, obligations based on unjust enrichment (*ungerechtfertigte Bereicherung*) or tort (*Delikt*) and including all interest and commissions due or to become due thereon (in each case, whether due, owed or incurred alone or jointly and severally with any other person, whether actually or contingently and whether as principal, surety or otherwise), as well as all costs, fees and expenses, including court or out-of-court cost and attorney's expenses arising in connection therewith or with the protection, preservation, or realization of the security interest granted hereunder (the **Secured Obligations**), irrespective of any intermediate discharge of any but not all of the Secured Obligations.

3. Notification and Registration of Pledge

- (a) The Pledgor (or in its default the Pledgee on its behalf) shall within 30 (thirty) Business Days as of the date hereof file a request to register, or procure that local advisors approved by the Pledgee will file a request with the competent registry to register the Pledge over all Intellectual Property Rights (i) registered in the relevant patent, trademark or other applicable registers in the United States of America and Switzerland and (ii) registered as a EU trademark with the European Intellectual Property Office.

- (b) Notwithstanding Clause 3(a), the Pledgor shall within 30 (thirty) Business Days upon reasonable request by the Pledgee file a request to register, or procure that local advisors approved by the Pledgee will file a request with the competent registry, to register the Pledge over all Intellectual Property Rights in the relevant patent, trademark or other applicable registers, in each case to the extent permitted in the relevant jurisdiction.
- (c) For that purpose, the Pledgor shall timely do all acts and things and permit all acts and things to be done which are necessary for the registration of the Pledgor's ownership, if applicable and commercially reasonable, and the Pledge in the relevant registers.
- (d) The Pledgor undertakes to promptly notify the Pledgee upon the acquisition of any future Intellectual Property Rights and, within 5 (five) Business Days upon becoming aware of the acquisition of the respective Intellectual Property Rights to provide an amended Intellectual Property Rights List to the Pledgee, such list to be substantially in the form of Annex 1 hereto and duly signed by the Pledgor.

4. Delivery of Additional Documents

On the date of this Agreement, the Pledgor shall deliver to the Pledgee, to the extent that such documents have not been delivered under the Investment Agreement, the following documents:

- (a) an up-to-date and officially certified excerpt from the Commercial Register of the Canton of Ticino relating to the Assignor (certification date no older than 20 (twenty) Business Days prior to the date of this Agreement);
- (b) a certified copy of the current articles of incorporation (*Statuten*) of the Pledgor;
- (c) a copy of a unanimous resolution of the board of directors wherein the entry into this Agreement and the granting of the security interest and the Pledge as provided for hereunder has been duly approved;
- (d) a copy of a unanimous resolution of the shareholders wherein the entry into this Agreement and the granting of the security interest and the Pledge as provided for hereunder has been duly approved; and
- (e) the Intellectual Property Rights List.

5. Rights and Obligations relating to Intellectual Property Rights

- (a) Until the occurrence of an Event of Default, the Pledgor shall be free to deal with those assets on the terms of the Investment Agreement. Furthermore, the Pledgor shall, at its sole expense, maintain and actively defend the Intellectual Property Rights and promptly react against any actual or potential infringement, claim or unauthorized use that comes to its attention in connection with the Intellectual Property Rights as well as any acts by

third parties in connection with the Intellectual Property Rights which may constitute unfair competition.

- (b) The Pledgor shall promptly inform (and send copies of respective correspondence to) the Pledgee of all activity undertaken (other than activity undertaken in the ordinary course of business) for the maintenance and defense of the Intellectual Property Rights.

6. Representations and Warranties

The Pledgor hereby represents and warrants to the Pledgee that as of the date of this Agreement:

- (a) the Pledgor is duly incorporated and organized and validly existing under the laws of Switzerland;
- (b) the Pledgor has the full corporate power and authority to own and use its respective assets and properties and to conduct its respective business as the same are presently conducted;
- (c) the Pledgor has the necessary power and authority to enable it to enter into, and perform its obligations under, this Agreement;
- (d) the Pledgor is neither insolvent nor subject to any composition, bankruptcy or other insolvency proceedings;
- (e) the Intellectual Property Rights as listed in Annex 1 exist as of the date hereof and are valid and enforceable;
- (f) all consents, approvals and authorizations have been duly obtained and corporate resolutions duly passed to enable the Pledgor to enter into, and perform its obligations under, this Agreement, and the validity and enforceability of this Agreement or any obligations of the Pledgor hereunder is not subject to any restriction of any kind, consent or other (legal or non-legal) requirement or condition that has not been satisfied and is not in breach of the corporate powers of the Pledgor;
- (g) no agreements relating to the Intellectual Property Rights have been entered into, and no shareholders' meeting or board meeting of the Pledgor has been held, is called for or planned, in which resolutions were or are proposed to be, passed or approved that could negatively affect the Pledge or any other right of the Pledgee under this Agreement;
- (h) this Agreement (i) constitutes legal and valid obligations binding on the Pledgor, (ii) creates an effective and perfected first ranking Pledge, and (iii) is enforceable against the Pledgor in accordance with its terms;

- (i) there are no agreements between the Pledgor and any third party relating to the Intellectual Property Rights that are opposed to the obligations of the Pledgor and the rights of the Pledgee under this Agreement or the realization or the proceeds of enforcement of the Intellectual Property Rights;
- (j) the documents referred to in Clauses 4(a), (b) and (e) are accurate, complete and up-to-date;
- (k) the resolutions referred in Clause 4(c) and (d) have been duly passed in meetings duly convened or otherwise in the manner set forth therein, accurately reflect the resolutions and other matters reflected therein and are in full force and effect and have not been revoked or amended;
- (l) the execution of, and performance of its obligations under this Agreement by the Pledgor does not contravene or violate any Swiss law, authorization or order applicable to the Pledgor or conflict with, result in a breach of the terms and provisions of, or constitute a default or require any consent under, any material agreement to which the Pledgor is a party or by which it is bound;
- (m) the Pledgor is the sole legal and beneficial owner of the Intellectual Property Rights and such rights are held by the Pledgor in free and unencumbered property, they are duly registered in the respective registries and are not subject to any pledges, liens, rights of set-off or third party rights of any nature, other than licenses granted in its ordinary course of business with regard to certain trademarks; and
- (n) the Pledgor has not assigned, transferred or otherwise disposed of any of its rights, title and interest in the Intellectual Property Rights.

The representations and warranties set out in this Clause 6 are deemed to be repeated by the Pledgor whenever the representations and warranties in the Investment Agreement are repeated, in each case with reference to the facts and circumstances then existing.

7. Undertakings

Except in accordance with the terms of the Investment Agreement, the Pledgor hereby undertakes for as long as this Agreement and the Pledge remain in effect:

- (a) not to cause or approve the resolutions referred to in Clause 4(c) and (d) to be revoked or amended;
- (b) to take any action and to do all things necessary to ensure that future Intellectual Property Rights are valid and enforceable;
- (c) to take any action and to do all things reasonably necessary and appropriate to protect and maintain the value of the Intellectual Property Rights;

- (d) to do all acts and things necessary to maintain the legal validity and prevent any deterioration of the legal standing of all Intellectual Property Rights with respect to which the Pledge has been registered in accordance with Clause 3, in particular to defend the Intellectual Property Rights against each and every nullity claim by third parties and to take at its own costs legal steps against each and every violation of the Intellectual Property Rights to the extent such acts, things or steps are reasonable in view of the value of the relevant patent or trademark;
- (e) not to sell, transfer or otherwise dispose of, or create a subsequent pledge, charge, lien or third party right of any nature on any of the Intellectual Property Rights without the prior written consent of the Pledgee, with the exception of licenses granted in its ordinary course of business with regard to certain trademarks;
- (f) to submit to the Pledgee on a semi-annual basis and, in addition, within 10 (ten) Business Days upon request by the Pledgee an updated Intellectual Property Rights List, such list to be substantially in the form of Annex 1 hereto and duly signed by the Pledgor. It is understood, however, that all Intellectual Property Rights are pledged to the Pledgee irrespective of whether they are included in the Intellectual Property Rights List, and regardless of whether the Intellectual Property Rights List is delivered to the Pledgee;
- (g) to notify the Pledgee as soon as possible after becoming aware of it of any event or circumstances which effectively have an adverse effect on (i) the validity or enforceability of this Agreement or the Pledge, (ii) the validity of any Intellectual Property Right and (iii) any measures proposed to be taken in order to protect the legal validity and prevent any deterioration of the legal standing of the Intellectual Property Rights, in particular where the Pledge has not been registered in accordance with Clause 3;
- (h) upon occurrence of an Event of Default to do all acts and things as the Pledgee requires and are necessary, and procure that any and all such acts and things be done, including to properly effect the realization of the Intellectual Property Rights; and
- (i) to promptly execute and deliver at its own expense all further instruments and documents, and take all further action that the Pledgee may request, to (i) create, perfect, protect, maintain and enforce the security created or purported to be created hereunder and otherwise implementing this Agreement, (ii) enable the Pledgee to exercise and enforce its rights, discretions and remedies granted under this Agreement or by law, (iii) enable the Pledgee to assess the value of the Pledge and the Intellectual Property Rights, and (iv) facilitate the realization of the security on and after the occurrence of an Event of Default.

8. Enforcement of Pledge

- (a) In the event that an Event of Default has occurred, the Pledgee shall have the right, but not the obligation, to enforce the Pledge, at its discretion, by either:

- (i) realizing the Pledge without regard to the provisions of the DEBA by private sale (*private Verwertung*) or, to the extent permitted, acquire the Intellectual Property Rights in its own name and on its own account (*Selbsteintritt*);
 - (ii) enforcement proceedings pursuant to the DEBA; or
 - (iii) enforcement proceedings pursuant to other applicable laws.
- (b) In the course of private enforcement (*Private Verwertung*), the Pledgee may either sell the Intellectual Property Rights to a third party or acquire any and all or part of the Intellectual Property Rights on its own behalf (*Selbsteintritt*), in each case on arm's length terms. The Pledgee shall render an account to the Pledgor regarding the private enforcement.
- (c) With regard to private enforcement (*Private Verwertung*), the Pledgor hereby authorizes the Pledgee to be its attorney and in the Pledgor's name and on its behalf to execute, deliver and perfect all documents and to do all things that are required or expedient in this respect.
- (d) The Parties agree in advance that a sale according to article 130 DEBA (*Freihandverkauf*) shall be permissible.
- (e) Notwithstanding the foregoing and notwithstanding the provision of article 41 DEBA, the Pledgee is at liberty to institute or pursue the enforcement of the Secured Obligations pursuant to regular debt enforcement proceedings without having first realized the Pledge (waiver of the *beneficium excussionis realis*).

9. Application of Proceeds

Any proceeds received by the Pledgee under this Agreement, in particular in connection with the enforcement of the Pledge, shall be applied towards satisfaction of the Secured Obligations in accordance with the Investment Agreement.

10. Security for Third Party Obligations

10.1 Waiver of Legal Subrogation and Defences

If and to the extent the Secured Obligations are not only owed by the Pledgor but also by third parties, and if and to the extent the Pledgor satisfies the Secured Obligations in full or in part (including by enforcement of the Pledge), the following provisions shall apply:

- (a) Until satisfaction of the Secured Obligations in full, the legal subrogation (*gesetzlicher Forderungsübergang*) pursuant to article 110, 149 CO (or any other applicable provision) or under any other applicable law shall not apply. For the avoidance of doubt, the claim for indemnity (article 148 para. 2 OR) shall not be affected thereby.

- (b) The Pledgor may request the transfer to it of non-accessory security rights (*nicht-akzessorische Sicherungsrechte*) which have not been provided by the Pledgor only upon satisfaction of the Secured Obligations in full and only if and to the extent the respective security provider has approved the transfer to the Pledgor.
- (c) The Pledgor hereby expressly waives its defences based on defences any Existing Shareholder or member of the Group might have against any of the Secured Obligations (*Einreden des Hauptschuldners*).

10.2 Limitation of Security

Notwithstanding anything to the contrary in this Agreement, the obligations of the Pledgor and the rights of the Pledgee under this Agreement are subject to the following limitations:

- (a) If and to the extent the security interest granted by the Pledgor under this Agreement secures obligations of its (direct or indirect) parent company (upstream security) or its sister companies (cross-stream security) (the **Upstream or Cross-Stream Secured Obligations**) and if and to the extent using the proceeds from the enforcement of such security interest to discharge the Upstream or Cross-Stream Secured Obligations would constitute a repayment of capital (*Einlagerückgewähr/Kapitalrückzahlung*), a violation of the legally protected reserves (*gesetzlich geschützte Reserven*) or the payment of a (constructive) dividend (*Gewinnausschüttung*) under Swiss corporate law, the proceeds from the enforcement of such security interest to be used to discharge the Upstream or Cross-Stream Secured Obligations shall be limited to the maximum amount of the Pledgor's freely disposable shareholder equity at the time of enforcement (the **Maximum Amount**); provided that such limitation is required under the applicable law at that time; provided, further, that such limitation shall not free the Pledgor from its obligations in excess of the Maximum Amount, but merely postpone the performance date of those obligations until such time or times as performance is again permitted under then applicable law. This Maximum Amount of freely disposable shareholder equity shall be determined in accordance with Swiss law and applicable Swiss accounting principles, and, if and to the extent required by applicable Swiss law, shall be confirmed by the auditors of the Pledgor on the basis of an interim audited balance sheet as of that time.
- (b) In respect of Upstream or Cross-Stream Secured Obligations, the Pledgor shall, as concerns the proceeds resulting from the enforcement of the security interest under this Agreement, if and to the extent required by applicable law in force at the relevant time:
 - (i) procure that such enforcement proceeds can be used to discharge Upstream or Cross-Stream Secured Obligations without deduction of Swiss Withholding Tax by discharging the liability to such tax by notification pursuant to applicable law rather than payment of the tax;
 - (ii) if the notification procedure pursuant to sub-paragraph (i) above does not apply, deduct the Swiss Withholding Tax at such rate (currently 35% at the date of this

11. Release of Pledge

- (a) The Intellectual Property Rights or, in case of an enforcement of some but not all of the Intellectual Property Rights, the remainder thereof, shall be released from the Pledge and returned to the Pledgor at its cost and risk if and when the Pledgee, acting reasonably, determines that all Secured Obligations have been irrevocably paid and discharged in full in accordance with the terms of the Investment Agreement and no further Secured Obligations are capable of arising (including, for the avoidance of doubt, following the termination of the Investment Agreement pursuant to clause 2.4(d) of the Investment Agreement), it being understood that the Pledgee shall not unreasonably delay or withhold the release of the Pledge.
- (b) The Pledgee will not make, and shall not be deemed to have made, any representation or warranty, whether express or implied, with respect to any Intellectual Property Rights released from the Pledge and returned to the Pledgor under this Clause 11, except that at the date of such release of the Intellectual Property Rights from the Pledge, such Intellectual Property Rights are free and clear, on such date, of any third-party rights arising from the Pledgee's acts.

12. Reinstatement

Where any discharge in respect of the Secured Obligations is made, in whole or in part, and any amount paid pursuant to any such discharge must be repaid by the Pledgee, the Pledgee will have or continue to have a Secured Obligation and, in case the Intellectual Property Rights have been released from the Pledge, the Pledgor shall undertake all actions that are necessary for the reinstatement of the Pledge. Such reinstatement shall, to the extent required, include a reinstatement of this Agreement and the Pledge shall continue as if there had been no discharge.

13. Indemnity

- (a) The Pledgor shall hold the Pledgee harmless of, and indemnify the Pledgee against, any losses, damages, claims, reasonable costs or reasonable expenses (including legal fees) which the Pledgee may suffer in connection with anything done or omitted to be done in the due exercise of the powers contained herein or in any related document including (i) any breach of any representation, warranty or undertaking contained in this Agreement, and (ii) the enforcement of the Pledge granted under this Agreement, unless the Pledgee acts in wilful misconduct (*Absicht*) or gross negligence (*grobe Fahrlässigkeit*).
- (b) The Pledgee shall not be liable for any loss or damage suffered by the save in respect of such loss or damage which is suffered as a result of wilful misconduct (*Absicht*) or gross negligence (*grobe Fahrlässigkeit*) of the Pledgee.

14. Duration; Independence

- (a) The Pledge shall not cease to exist if the Secured Obligations have been discharged only partially or temporarily.
- (b) This Agreement shall create a continuing Pledge and no change, amendment, restatement or supplement whatsoever in the Investment Agreement or in any document or agreement related to the Investment Agreement shall affect the validity or the scope of this Agreement and the Pledge nor the obligations which are imposed on the Pledgor pursuant to it.
- (c) This Agreement and the Pledge are independent from any other security or guarantee which may have been or will be entered into for the benefit of the Pledgee. None of such other security or guarantee shall prejudice, or shall be prejudiced by, or shall be merged in any way with this Agreement or the Pledge.

15. General Provisions

15.1 No Waiver

No failure or delay by any Party in exercising any right, power or privilege granted under this Agreement shall operate as a waiver thereof nor shall any single or partial exercise of any right, power or privilege preclude any other or further exercise thereof or the exercise of any other right, power or privilege.

15.2 Notices

All notices or other communications to be given under or in connection with this Agreement shall be made pursuant to and in accordance with the relevant form of the Investment Agreement, in particular clause 26 of the Investment Agreement.

15.3 Entire Agreement

This Agreement, including the annexes and any other documents referred to herein, constitutes the entire agreement and understanding among the Parties with respect to the subject matter hereof, and shall supersede all prior oral and written agreements or understandings of the Parties relating hereto. All references to this Agreement shall be deemed to include the annexes hereto.

15.4 Amendments and Waivers

This Agreement (including this Clause 15.4) may only be modified or amended by a document signed by all Parties. Any provision contained in this Agreement may only be waived by a document signed by the Party waiving such provision.

15.5 Transfer of Rights and Obligations

No Party shall be entitled to assign or in any other way dispose of any or all of its rights or obligations under this Agreement, without the written consent of the other Party, save that the Pledgee shall be entitled to assign its rights and obligations to a member of the Investor's Group (as defined in the Investment Agreement).

15.6 Severability

Should any part or provision of this Agreement be, be held, or become illegal, invalid or unenforceable in any respect by any competent arbitral tribunal, court, governmental or administrative authority having jurisdiction, the legality, validity or enforceability of the remaining provisions of this Agreement shall nonetheless remain valid and not in any way be affected or impaired. In such case, the Parties shall replace the illegal, invalid or unenforceable provision with such valid and enforceable provision which best reflects the commercial and legal purpose of the replaced provision and shall execute all agreements and documents required in this connection.

16. Governing Law and Jurisdiction

16.1 Governing Law

This Agreement and the Pledge shall be governed by and construed in accordance with the substantive laws of Switzerland.

16.2 Place of Jurisdiction

The exclusive place of jurisdiction for any dispute, claim or controversy arising under, out of or in connection with or related to the Agreement (or subsequent amendments thereof), including, without limitation, disputes, claims or controversies regarding its existence, validity, interpretation, performance, breach or termination, shall be the city of Zurich, Switzerland.

The Pledgee shall have the right to institute legal proceedings against the Pledgor before any other competent court or authority, in which case Swiss law shall nevertheless be applicable as provided in Clause 16.1.
