TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "<u>Termination</u>"), dated as of February 2, 2018, is made by HPS Investment Partners, LLC, as Collateral Agent (in such capacity, the "<u>Collateral Agent</u>"), in favor of AVM Industries, LLC, an Ohio limited liability company, Carter Fuel Systems, LLC, a Delaware limited liability company, and Trico Products Corporation, a New York corporation (each, a "<u>Pledgor</u>" and collectively, the "<u>Pledgors</u>"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement (as defined below).

WHEREAS, pursuant to that (i) certain Term Loan Pledge and Security Agreement, dated as of May 26, 2016 (as it may be amended, restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement"), among the Pledgors, the other Grantors (as defined therein) party thereto and the Collateral Agent and (ii) certain Trademark Security Agreement, dated as of May 26, 2016 (the "Trademark Security Agreement") executed by the Pledgors in favor of the Collateral Agent, the Pledgors pledged and granted to the Collateral Agent a security interest in and continuing lien on all of each Pledgor's right, title and interest in, to and under the Trademark Collateral;

WHEREAS, the security interest in the Trademark Collateral pledged and granted by each Pledgor to the Collateral Agent under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on May 30, 2016, at Reel 5802, and Frame 0518; and

WHEREAS, the Collateral Agent has agreed to terminate the Trademark Security Agreement to terminate, release and discharge its security interest and lien on all Trademark Collateral (as defined in the Trademark Security Agreement) including, without limitation, those United States Trademark Registrations and Trademark Applications listed on Schedule 1 attached hereto (the "Released Trademark Collateral").

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Pledgors secured by the Released Trademark Collateral pursuant to the Security Agreement and the Trademark Security Agreement, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

- 1. The Collateral Agent hereby terminates, releases and discharges all of its mortgages, liens, and security interests in all of each Pledgors' right, title and interest in, to and under the Released Trademark Collateral and hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Released Trademark Collateral to the Pledgors.
- 2. The Collateral Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.
- 3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT

REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
