**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of January 10, 2018, by MADISON CAPITAL FUNDING LLC, in its capacity as Agent for the Lenders (in such capacity, “Grantee”). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Assignment described below.

WITNESSETH:

WHEREAS, Grantee and JWC Environmental, LLC, a California limited liability company (“Grantor”), were parties to certain Trademark Security Agreements dated as of August 3, 2011, June 21, 2016 and January 6, 2017, respectively (the “Assignments”), pursuant to which Grantor granted a security interest to Grantee in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including, without limitation, the Trademarks set forth on Schedule A hereto; and

WHEREAS, the Assignments were recorded by the United States Trademark and Trademark Office on September 15, 2011, at Reel 4623, Frame 0433, June 22, 2016, at Reel 5818, Frame 0699 and January 6, 2017, at Reel 005961, Frame 0065, respectively; and

WHEREAS, Grantor has requested that Grantee release its security interest in and lien on the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases, terminates and discharges its security interest in all of Grantor’s right, title and interest in, to and under the following (collectively the “Trademark Collateral”):

a. each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

b. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the goodwill associated with each such Trademark.


2. Grantee hereby releases its security interest in and lien on the Trademark Collateral.

3. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee’s right, title and interest in and to the Trademark Collateral.
