## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("**Release**") is made and effective as of February 16, 2018 and granted by Venture Lending and Leasing VI, Inc. ("**VLL6**") and Venture Lending & Leasing VII, Inc. ("**VLL7**"), both Maryland corporations) in favor of the predecessor in interest, Bot Home Automation, Inc., now Ring Inc., a Delaware corporation (the "**Grantor**") and its successors, assigns and legal representatives.

WHEREAS, pursuant to the Security Agreement dated July 14, 2014 by and between Grantor and VLL6 and VLL7 (the "**Security Agreement**"), and recorded with the U.S. Patent and Trademark Office on July 17, 2014 at Reel/Frame No. 5324/0400, the Grantor granted VLL6 and VLL7 a Lien on and continuing security interest in, all of its right, title and interest in, to certain items of Grantor's Intellectual Property pledged by the Grantor described therein, including, without limitation, the United States trademark set forth on Schedule A attached hereto (collectively, the "**Trademark**") and all of the goodwill of the business connected with the use of, and symbolized by the Trademark;

WHEREAS, the Grantor has paid all of its outstanding indebtedness to VLL6 and VLL7; and

WHEREAS, the Grantor has requested that VLL6 and VLL7 enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest that VLL6 and VLL7 may have in the Trademark pursuant to the Security Agreement.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, VLL6 and VLL7, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels, and releases its Lien on and continuing security interest in the Trademark, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark, and any and all right, title and interest of VLL6 and VLL7 in the Trademark shall hereby terminate, cease and become void.

VLL6 and VLL7 agree to provide the Grantor with any information, and additional authorization and documentation necessary to effect the release of VLL6 and VLL7's security interest in the Trademark.
