RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement (this "Release") is made as of February 28, 2018, by ANTARES CAPITAL LP (as successor agent to General Electric Capital Corporation), in its capacity as Agent for the Lenders under (and as defined in) the Credit Agreement referred to below (the "Agent") for the benefit of VINVENTIONS USA, LLC, a North Carolina limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement (as defined below) or the Trademark Security Agreement (as defined below) as applicable.

W I T N E S S E T H:

WHEREAS, the Grantor and the Agent are parties to that certain (i) Credit Agreement, dated as of December 14, 2012 (as amended, restated or otherwise modified through the date hereof, the "Credit Agreement"); (ii) Guaranty and Security Agreement dated as of December 14, 2012 (as amended, restated or otherwise modified through the date hereof, the "Security Agreement"); and (iii) Trademark Security Agreement, dated as of December 14, 2012 (as amended, restated or otherwise modified through the date hereof, the "Trademark Security Agreement"), pursuant to which the Grantor has granted to the Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest of the Grantor in, to and under the Trademark Collateral, including the trademarks set forth on Schedule I hereto; and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 17, 2012 at Reel 4921 and Frame 0217; and

WHEREAS, Grantor has requested that the Agent release, and the Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Trademark Security Agreement to the Trademark Collateral and any right, title or interest of the Agent in such Trademark Collateral shall hereby terminate, cease and become void. The Agent hereby assigns, transfers and conveys any and all right, title or interest of the Agent in the Trademark Collateral to the Grantor.

2. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
