**RELEASE OF SECURITY INTEREST

WHEREAS, pursuant to the Confirmatory Grant of Security Interest in United States Trademarks, dated as of June 9, 2010 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on June 15, 2010, at Reel/Frame No. 4224/0733, the Supplemental Grant of Security Interest in United States Trademarks, dated as of October 28, 2011, and recorded with the U.S. Patent and Trademark Office on November 29, 2011, at Reel/Frame No. 4667/0243, the Supplemental Grant of Security Interest in United States Trademarks, dated as of January 13, 2014, and recorded with the U.S. Patent and Trademark Office on January 14, 2014, at Reel/Frame No. 5192/0327, the Supplemental Grant of Security Interest in United States Trademarks, dated as of July 25, 2016, and recorded with the U.S. Patent and Trademark Office on July 25, 2016, at Reel/Frame No. 5842/0055, Grantor granted to the Agent a security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademarks set forth on Schedule A attached hereto (the "Released Registered Trademarks"); and

WHEREAS, Grantor has requested that the Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Trademarks; and


