Assignor hereby assigns to Assignee all right, title and interest in and to (i) all applications and registrations (US and/or foreign), including, but not limited to, the marks depicted in **Schedule A**; (ii) any and all trademark, service mark, tradename, logos, copyright, and intellectual property rights, including rights of priority, in the marks/names listed in (i) above ((i)-(ii) collectively, the "Marks"); (iii) any and all goodwill of the business associated with the Marks; (iv) all causes of action, claims and demands and other rights for, or arising from, any infringement or misappropriation, including past infringements and misappropriations, of the Marks; and (v) any royalties or other consideration owed in connection with use of the Marks after the Effective Date.
2. Assignor further agrees, without further consideration, to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Marks, goodwill and all other rights hereby conveyed.

**IN WITNESS WHEREOF**, the Parties have caused this Assignment to be duly executed by their respective authorized officers, all as of the date and year first above written.


