SECURITY AGREEMENT**

This **APPOINTMENT OF SUCCESSOR AGENT UNDER INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Agreement"), dated as of September 1, 2016, is by **ANTARES CAPITAL LP** (individually, "Antares"), acting in its capacity as the current and resigning administrative agent (in such capacity, the "Retiring Agent") and **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national bank (individually, "Wells Fargo"), acting in its capacity as the successor administrative agent (in such capacity, the "Successor Agent").

**RECITALS:**

**WHEREAS**, the entities listed in Annex A hereto (collectively, "Grantors"), and Retiring Agent (as successor Agent to General Electric Capital Corporation) are parties to those certain intellectual property security agreements identified in Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, collectively, the "Agreements") covering certain intellectual property set forth on Exhibit B attached hereto; and

**WHEREAS**, pursuant to that certain Agreement Regarding Agency Resignation, Appointment and Acceptance and Amendment No. 1 to Credit Agreement, dated as of the date hereof, by and among Antares, as the Retiring Agent, Wells Fargo, as Successor Agent, and the Borrowers and Lenders party thereto, Retiring Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreements, in each instance, in its capacity as administrative agent and, if applicable, collateral agent.

**NOW, THEREFORE**, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retiring Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreements.




