ASSIGNMENT OF TRADEMARKS AND DOMAIN NAMES

This ASSIGNMENT OF TRADEMARKS AND DOMAIN NAMES (this "Assignment"), is effective as of this 31st day of October, 2016 (the "Effective Date"), by and between Gerresheimer Glass Inc., a Delaware corporation (the "Assignor"), and Kimble Kontes LLC, a Delaware limited liability company (the "Company") (collectively, the "Parties").

WITNESSETH:

WHEREAS, pursuant to that certain Purchase and Sale Agreement by and among Duran, Inc., Duran Group GmbH, Duran Life Science Holding GmbH, Kimble Chase Life Science and Research Products, LLC, and Kimble Chase Holding LLC, dated September 10, 2016 (the "PSA"), Assignor agreed to convey, transfer, and assign to Duran, Inc., among other assets, certain intellectual property of Assignor, and has agreed to execute and deliver this Assignment of Trademarks and Domain Names, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions;

WHEREAS, Duran, Inc. has designated the Company as assignee of the Assigned Trademarks and the Assigned Domain Names (defined below);

WHEREAS, Assignor is the (i) owner of the specific trademarks listed on Schedule 1 attached hereto (collectively, the "Assigned Trademarks") that relate to the Company's business, and have agreed to sell, assign and convey to the Company these Assigned Trademarks, including all right, title and interest in and to these Assigned Trademarks;

WHEREAS, except as specified herein, Assignor or its affiliate is the listed registrant of the specific Internet domain names listed on Schedule 2 attached hereto (collectively, the "Assigned Domain Names") that relate to the Company's business, and Assignor has agreed to sell, assign and convey to the Company these Assigned Domain Names, or shall cause its affiliate to sell, assign and convey to the Company these Assigned Domain Names, including all right, title and interest in and to these Assigned Domain Names; and

WHEREAS, the Company desires to accept all of Assignor's right, title and interest in and to the Assigned Trademarks and Assigned Domain Names.

NOW THEREFORE, for good and valuable consideration exchanged by the Company and Assignor, the receipt and sufficiency of which are hereby acknowledged by the Parties:

1. Assignment. Assignor does hereby irrevocably sell, assign, convey and transfer to the Company all of its right, title and interest (whether statutory, common law or otherwise) in and to the Assigned Domain Names, the

Assigned Trademarks, and all goodwill associated with any of Assigned Trademarks; provided, however, that notwithstanding anything to the contrary herein or otherwise, with respect to the kimblechase.cn and kimble-chase.cn domain names (the "Chinese Domain Names"), Assignor shall sell, assign, convey and transfer all of its right to access and use such domain names consistent with past practices as the Chinese Domain Names are owned by Wuxi Weizhiyuang Automobile, Wuxi, China. The foregoing assignment of the Assigned Trademarks and Assigned Domain Names includes the exclusive rights to (a) bring actions, defend against or otherwise recover for infringements, and the right to the profits or damages due or accrued, arising out of or in connection with any and all past, present or future infringements of the Assigned Trademarks, (b) apply for, make filings with respect to and maintain all registrations, renewals and extensions of the Assigned Trademarks, (c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the Assigned Trademarks and (d) all other rights of any kind whatsoever of Assignor in or to the Assigned Trademarks or the Assigned Domain Names.

2. Acknowledgment. Assignor hereby acknowledges that from and after the date hereof, the Company shall be the sole and exclusive owner of all of Assignor's right, title and interest in and to the Assigned Trademarks and Assigned Domain Names (except with respect to the Chinese Domain Names).
3. Further Assurances. Each of Assignor and the Company agrees, without any further consideration, to execute and deliver such other documents and to take such other actions as the other may reasonably request in order to effectuate the purposes of this Assignment and to consummate the actions contemplated hereby, including the execution of any documents as may be necessary to assist the Company in recording and effectuating the assignment contemplated herein with the United States Patent and Trademark Office, as well as corresponding entities or agencies in any country or jurisdiction that may exercise authority over any of the Assigned Trademarks or Assigned Domain Names. The Company shall have the right to record this Assignment with all applicable governmental authorities and registrars so as to perfect its ownership of the Assigned Trademarks, if applicable. Any fees charged by any applicable national or international office or registrar in relation to the recordation of the assignment shall be borne by the Company, and the Company shall promptly reimburse Assignor for any and all such fees actually paid by Assignor.
4. Assignor hereby requests that the Commissioner for Trademarks at the United States Patent and Trademark Office (the "Commissioner"), as well as his or her counterparts at the corresponding entities or agencies in any country or jurisdiction that may exercise authority over any of the Assigned Trademarks, to record this Assignment.


5. Assignor hereby requests that the relevant domain name registrars and any other appropriate domain name registration authorities that exercise authority over the Assigned Domain Names, to transfer the Assigned Domain Names to the Company.
6. Terms of the PSA. The Parties acknowledge and agree that this Assignment is entered into pursuant to the PSA, to which reference is made for a further statement of the rights and obligations of Assignor and Duran, Inc. with respect to the Assigned Trademarks and Assigned Domain Names. The representations, warranties, covenants, agreements, and indemnities contained in the PSA shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the PSA and the terms hereof, the terms of the PSA shall govern.
7. Binding Effect: Assignment. This Assignment shall be binding upon and inure solely to the benefit of the parties hereto and their respective successors and permitted assigns.
8. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York, without regard to any conflict of laws provisions thereof that would result in the application of the laws of another jurisdiction. Each of the Company and Assignor hereby consents to and submits to the exclusive jurisdiction and venue of the federal and state courts located in the State of New York for enforcement or interpretation of this Assignment, and for any disputes under or arising out of this Assignment.
9. Counterparts; Effectiveness. This Assignment may be executed in counterparts, each of which will be an original as regards any party whose signature appears thereon and both of which together will constitute one and the same instrument.


