## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 21, 2018 (this “Release”), is made by BB&T Capital Partners Mezzanine Fund II, LP (“Lender”), in favor of SSG International, LLC, a Michigan limited liability company corporation (“Grantor”).

**WHEREAS**, pursuant to that certain Intellectual Property Security Agreement dated January 2, 2015, (“Security Agreement”), by and between the Grantor and the Lender, the Grantor granted to the Lender a security interest in Grantor’s entire right, title and interest in, to, and under all Trademarks and proceeds and products thereof.

**WHEREAS**, pursuant to the Security Agreement, Grantor executed and delivered to the Lender, a Grant of Security Interest in Trademarks (“Instrument”).

**WHEREAS**, the Instrument was recorded at the United States Patent and Trademark Office (“USPTO”) on January 5, 2015, at Reel 5434, Frame 0842.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Lender and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** The Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in, to, and under the Trademarks listed on Exhibit A attached hereto, and the proceeds and products thereof, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release and obligations of the parties hereunder, and all of their successors, assigns, and transferees, shall be governed by and construed in accordance with the laws of the State of New York (without regard to its conflict of laws provisions).



