NOTICE OF SECURITY INTERESTS IN TRADEMARKS dated as of April 6, 2018 (this "<u>Trademark Security Agreement</u>"), made by Rotech Healthcare Inc., a Delaware corporation (the "Obligor"), in favor of SunTrust Bank, as Administrative Agent (the "Administrative Agent").

WHEREAS, under the terms of the Security and Pledge Agreement entered into as of April 6, 2018 among the Obligor, the other obligors party thereto, and the Administrative Agent (amended, modified, supplemented, increased, extended, restated, refinanced and replaced from time to time, the "Security Agreement"), the Obligors have granted to the Administrative Agent, for the benefit of the holders of the Secured Obligations, a security interest in, among other property, certain intellectual property of the Obligors, and have agreed as a condition thereof to execute this Trademark Security Agreement for recording with the United States Patent and Trademark Office (the "USPTO").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Obligor agrees as follows:

SECTION 1. **Terms.** Capitalized terms used in this Trademark Security Agreement and not otherwise defined herein have the meanings specified in the Security Agreement.

SECTION 2. **Grant of Security Interest** To secure the prompt payment and performance in full when due, whether by lapse of time, acceleration, mandatory prepayment or otherwise, of the Secured Obligations, each Obligor hereby grants to the Administrative Agent, for the benefit of the holders of the Secured Obligations, a continuing security interest in, and a right to set off against, any and all right, title and interest of such Obligor in and to all of the following, whether now owned or existing or owned, acquired, or arising hereafter (collectively, but excluding any Excluded Property, the "<u>Trademark Collateral</u>"):

- (a) all trademarks, service marks, corporate names, company names, business names, trade dress, logos and taglines, all registrations thereof (if any), and all registration and recording applications filed in connection therewith, including registrations and registration applications in the USPTO (except for "intent-to-use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. §1051, for which an amendment to allege use or a statement of use has not been filed under Sections 1(c) and 1(d) of Lanham Act, respectively, or, if filed, has not been deemed in conformance with Section 1(a) of the Lanham Act or examined and accepted by the United States Patent and Trademark Office, but intent-to-use applications are excepted only to the extent that, and solely during the period if any in which, the grant of a security interest therein would impair the validity or enforceability of such "intent-to-use" applications), and all renewals thereof, including those listed on Schedule I hereto; and
 - (b) all goodwill associated therewith or symbolized thereby.

SECTION 3. **Security for Obligations**. The grant of a security interest in the Trademark Collateral by the Obligor under this Trademark Security Agreement is made to secure the payment or performance, as the case may be, in full of the Secured Obligations.

SECTION 4. **Recordation**. The Obligor hereby requests and authorizes the USPTO to record this Trademark Security Agreement against the Trademark Collateral.

SECTION 5. **Counterparts.** This Trademark Security Agreement may be executed in two or more counterparts, each of which shall constitute an original but all of which when taken together shall constitute but one contract. Delivery of an executed counterpart to this Agreement by facsimile or other electronic transmission (including .pdf file) shall be as effective as delivery of a manually signed original.

SECTION 6. **Governing Law.** THIS TRADEMARK SECURITY AGREEMENT AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TRADEMARK SECURITY AGREEMENT AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND BE GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
