INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "Agreement"), is made and entered into on December 12, 2017, by and between Rock Bottom Restaurants, Inc., a Delaware corporation ("Assignor"), and Wadsworth Old Chicago, Inc., a Colorado corporation ("Assignee").

WHEREAS, the parties mistakenly and erroneously executed and filed that certain Intellectual Property Assignment Agreement (the "Unintended Assignment"), dated August 28, 2017 (the "Prior Date"), by and between Assignor and Assignee, with the United States Patent and Trademark Office ("USPTO"), recorded at Reel 006153 Frame 0589;

WHEREAS, the parties desire to rescind, revoke and terminate the Unintended Assignment in its entirety, with effectiveness from the Prior Date;

WHEREAS, it is the parties' intent that, subject to the recital that follows, Assignor still holds all right, title, and interest in and to certain intellectual property of Assignor that the Unintended Assignment purported to transfer to Assignee on the Prior Date;

WHEREAS, under the terms of this Agreement, Assignor desires to convey, transfer, and assign to Assignee certain intellectual property of Assignor, and has agreed to execute and deliver this Agreement for recording with the USPTO, and corresponding entities or agencies in any applicable jurisdictions;

NOW THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. <u>Rescission of Unintended Assignment</u>. The parties hereby rescind, revoke, and terminate the Unintended Assignment in its entirety, which rescission, revocation, and termination shall be effective as of the Prior Date.
- 2. <u>Assignment</u>. Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the following (collectively, the "Assigned IP"):
- (a) all trademark registrations and applications set forth on <u>Schedule 1</u> hereto and all renewals thereof, common law rights associated therewith, and goodwill symbolized thereby;
- (b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;
- (c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

- (d) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
- 3. Recordation and Further Actions. Assignor hereby authorizes the USPTO, and the officials of corresponding entities or agencies in any applicable jurisdictions, to record and register this Agreement upon request by Assignee. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned IP to Assignee, or any assignee or successor thereto.
- 4. <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.
- 5. <u>Successors and Assigns</u>. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
- 6. Governing Law. This Agreement and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Agreement and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Colorado, without giving effect to any choice or conflict of law provision or rule (whether of the State of Colorado or any other jurisdiction).
