## **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 2, 2018 (this "Termination"), is made by COMPUTERSHARE TRUST COMPANY, NATIONAL ASSOCIATION, as collateral agent (in such capacity, including any successor thereto, the "Collateral Agent"), in favor of INTERACTIVE NETWORK, INC., a Delaware corporation ("INI"), FRIENDFINDER NETWORKS INC., a Delaware corporation ("FFN" and together with INI, the "Issuers"), and each direct and indirect subsidiary of FFN (other than INI) from time to time party to the Trademark Security Agreement (as defined below) (the "Grantors"). Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement referenced below.

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of December 20, 2013 (the "Trademark Security Agreement 1"), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on January 13, 2014 at Reel 5192 and Frame 0001;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of March 31, 2014 (the "Trademark Security Agreement 2"), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on October 29, 2014 at Reel 5389 and Frame 0697;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of June 30, 2014 (the "Trademark Security Agreement 3"), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on October 29, 2014 at Reel 5389 and Frame 0764;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of September 30, 2014 (the "Trademark Security Agreement 4"), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on February 17, 2015 at Reel 5461 and Frame 0173;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of December 31, 2014 (the "Trademark Security Agreement 5"), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on February 17, 2015 at Reel 5461 and Frame 0290

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of March 31, 2015 (the "Trademark Security Agreement 6"), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on May 29, 2015 at Reel 5525 and Frame 0108;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of June 30, 2015 (the "Trademark Security Agreement 7"), in favor of the Collateral Agent,

which was recorded in the records of the United States Patent and Trademark Office on August 6, 2015 at Reel 5595 and Frame 0201;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of September 30, 2015 (the “Trademark Security Agreement 8”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on December 1, 2015 at Reel 5678 and Frame 0729;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of December 31, 2015 (the “Trademark Security Agreement 9”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on or about the date thereof;

**WHEREAS**, the Grantors entered into that certain Amended and Restated Trademark Security Agreement, dated as of December 31, 2015 (the “Trademark Security Agreement 10”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on March 1, 2016 at Reel 5743 and Frame 0383;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of March 31, 2016 (the “Trademark Security Agreement 11”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on or about the date thereof;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of June 30, 2016 (the “Trademark Security Agreement 12”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on or about the date thereof;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of September 30, 2016 (the “Trademark Security Agreement 13”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on or about the date thereof;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of September 30, 2017 (the “Trademark Security Agreement 14”), in favor of the Collateral Agent, which was recorded in the records of the United States Patent and Trademark Office on or about the date thereof;

**WHEREAS**, the Grantors entered into that certain Trademark Security Agreement, dated as of December 31, 2017 (the “Trademark Security Agreement 15” and along with Trademark Security Agreement 1, Trademark Security Agreement 2, Trademark Security Agreement 3, Trademark Security Agreement 4, Trademark Security Agreement 5, Trademark Security Agreement 6, Trademark Security Agreement 7, Trademark Security Agreement 8, Trademark Security Agreement 9, Trademark Security Agreement 10, Trademark Security Agreement 11, Trademark Security Agreement 12, Trademark Security Agreement 13 and Trademark Security Agreement 14, collectively the “Trademark Security Agreements”), in favor of the Collateral

Agent, which was recorded in the records of the United States Patent and Trademark Office on or about the date thereof;

**WHEREAS**, the obligations secured by the Trademark Collateral have been repaid; and

**WHEREAS**, the Collateral Agent has agreed to terminate and release its security interest in all of the Trademark Collateral, including, without limitation, the trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, in consideration of the provisions set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Collateral Agent hereby terminates the Trademark Security Agreements and hereby terminates, cancels and releases any and all security interests that it has in, to and under all Trademark Collateral.

2. Authorization to Record. The Collateral Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Termination.

3. Further Assurances. The Collateral Agent shall take all further actions and provide to the Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Termination, at the Grantors' sole expense, and without representation or warranty by the Collateral Agent.

4. Governing Law. This Termination shall be construed in accordance with and governed by the laws of the state of New York, without regard to conflict of laws principles.
