SECOND LIEN TRADEMARK SECURITY AGREEMENT

This SECOND LIEN TRADEMARK SECURITY AGREEMENT, dated as of May 7, 2018 (this “Trademark Security Agreement”), by and among BOYNE USA, INC., a Michigan corporation (the “Borrower”), certain Subsidiaries of the Borrower as identified on the signature pages hereto (such Subsidiaries, collectively with the Borrower, the “Grantors”) and WILMINGTON TRUST, NATIONAL ASSOCIATION (“Wilmington Trust”), as Second Priority Collateral Agent (the “Collateral Agent”).

Reference is made to (a) the Indenture dated as of April 11, 2018 (as amended, supplemented or otherwise modified from time to time, the “Indenture”) between the Borrower, as issuer, and Wilmington Trust, National Association, as trustee (the “Trustee”) and (b) the Second Lien Collateral Agreement dated as of May 7, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), by and among the Borrower, Boyne Properties, Inc., a Michigan corporation, the other Grantors from time to time party thereto and Wilmington Trust, as Collateral Agent. It is a condition to the issuance of the Notes that payment shall be secured by, among other things, a security interest in favor of the Collateral Agent for the benefit of the Second Priority Secured Parties in the Collateral. Each Grantor will receive substantial direct and indirect benefits from the execution, delivery and performance of the obligations under the Indenture and the Notes and each is, therefore, willing to enter into this Trademark Security Agreement. Accordingly, the parties hereto agree as follows:

SECTION 1. Defined Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Indenture or the Collateral Agreement, as applicable. The rules of construction specified in Section 1.3 of the Collateral Agreement also apply to this Trademark Security Agreement, *mutatis mutandis*.

SECTION 2. Grant of Security Interest in Trademark Collateral. As security for the payment and performance in full of the Second Priority Obligations, each Grantor pursuant to the Collateral Agreement did, and hereby does, grant to the Collateral Agent, its successors and assigns, for the benefit of the Second Priority Secured Parties, a security interest in all of such Grantor’s right, title and interest in the following assets now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time hereafter may acquire any right, title or interest (the “Trademark Collateral”):

(a) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, internet domain names, trade styles, service marks, logos, other business identifiers, whether registered or unregistered, designs and general intangibles of like nature, all registrations and recordings thereof, and all applications in connection therewith (other than each application to register any trademark or service mark prior to the filing under Applicable Law of a verified statement of use for such trademark or service mark) anywhere in the world, including those listed in Schedule I, (ii) all extensions, divisionals and renewals of any of the foregoing, (iii) all income, royalties, damages and payments now or hereafter due and/or payable under any of the foregoing or with respect to any of the foregoing, including damages or payments for past, present or future infringements of any of the foregoing,

(iv) the right to sue for past, present or future infringements of any of the foregoing and (v) all rights corresponding to any of the foregoing (including the goodwill and all other assets, rights and interests that uniquely reflect or embody such goodwill) throughout the world;

(b) all Trademark Licenses under which any Grantor is a licensee, including, those referred to in Schedule I; and

(c) all Proceeds with respect to any of the foregoing.

SECTION 3. Collateral Agreement. The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Collateral Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Trademark Security Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.


SECTION 4. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts (and by different parties hereto in separate counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Trademark Security Agreement by facsimile or in electronic (*i.e.*, “pdf” or “tif”) form shall be effective as delivery of a manually executed counterpart of this Trademark Security Agreement.






