RELEASE OF TRADEMARK COLLATERAL AGREEMENT

THIS RELEASE dated as of May 14, 2018 (this “Release”) is made by OAKTREE SPECIALTY LENDING CORPORATION, a Delaware corporation (f/k/a Fifth Street Finance Corp., successor in interest to Fifth Street Management LLC, a Delaware limited liability company) acting in its capacity as administrative agent (in such capacity, the “Agent”) under that certain Trademark Collateral Agreement, dated as of February 27, 2017 (as amended, supplemented or modified and in effect from time to time, the “Trademark Collateral Agreement”) by and among TEACHING STRATEGIES, LLC, a Delaware limited liability company with an address of 4500 East-West Highway, 3rd Floor, Bethesda, MD 20814 (the “Grantor”) and the Agent.

WHEREAS, pursuant to the Trademark Collateral Agreement which was recorded in the records of the United States Patent and Trademark Office on March 2, 2017 at reel 6000, frame 0690, the Grantor granted to the Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached **Schedule A** (the “Trademark Collateral”);

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Collateral Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral.
