### RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE dated as of June 1, 2018 (this "Release"), from JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Administrative Agent"), for the several banks and other financial institutions (the "Lenders"), parties to the Credit Agreement, dated as of August 3, 2016 (as may be modified and supplemented and in effect from time to time, the "Credit Agreement"), among ICON Health & Fitness, Inc., HF Holdings, Inc., each of the other grantors party thereto, and the Administrative Agent, in favor of ICON HEALTH & FITNESS, INC., HF HOLDINGS, INC., UNIVERSAL TECHNICAL SERVICES, ICON IP, INC., FREE MOTION FITNESS, INC. and ICON – ALTRA LLC (collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of August 3, 2016, in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Collateral Agreement"), Grantors granted a security interest to the Administrative Agent in certain collateral, including Trademark Collateral;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 3, 2016, among the Administrative Agent and Grantors (the "<u>Trademark Security Agreement</u>"), Grantors, by reference to the Security Agreement, reaffirmed its intent to grant the security interest to the Administrative Agent specifically in that certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office (the "<u>USPTO</u>") on August 12, 2016 at Reel 5854 and Frame 0723; and

WHEREAS, the Administrative Agent now desires to release its security interest in those Trademarks owned by ICON – ALTRA LLC (including, without limitation, those Trademarks set forth on <u>Schedule 1</u> hereto) (the "<u>Released Collateral</u>");

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

- 1. <u>Definitions</u>. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.
- 2. <u>Release of Security Interest</u>. The Administrative Agent, for the benefit of the Secured Parties, hereby releases, terminates, cancels and discharges all of its security interest in the Released Collateral, and hereby re-assigns, conveys and transfers to the Grantors any right, title and interest that the Administrative Agent may have in the Released Collateral.
- 3. <u>Reservation of Rights.</u> For clarity, the Administrative Agent's security interest in and to all Collateral (as defined in the Collateral Agreement; including all other Trademark Collateral listed on Schedule I to Trademark Security Agreement) other than the Released Collateral shall remain in full force and effect.
- 4. <u>Further Assurances</u>. The Administrative Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
- 5. <u>Authorization to File</u>. The Administrative Agent authorizes and requests that the USPTO note and record the existence of the release hereby given.
