**RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS AND
TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENTS**

This Release of Security Interests in Patents and Trademarks and Termination of Patent and Trademark Security Agreements (the “**Release**”) is made and effective as of April 26, 2018 and granted by Balance Point Capital Partners, L.P., a Delaware limited partnership (the “**Lender**”), in favor of PlayMonster LLC f/k/a Patch Products, LLC, a Delaware limited liability company (the “**Debtor**”).

WHEREAS, pursuant to the terms and conditions of that certain Credit Agreement dated as of September 10, 2014 by and among Debtor, TS-Patch Holdings, LLC, and other parties from time to time and Lender, as amended, restated, supplemented or otherwise modified from time to time, Debtor and Lender entered into that certain Patent Security Agreement dated as of September 10, 2014, and that certain Amendment No. 1 To Patent Security Agreement dated August 19, 2016 (collectively the “**Patent Security Agreements**”), which were recorded with the United States Patent and Trademark Office on October 28, 2014 at Reel/Frame 034050/0601 and November 7, 2016 at Reel/Frame 040235/0852, respectively;

WHEREAS, the parties entered into that certain Trademark Security Agreement dated as of September 10, 2014, that certain Amendment No. 1 To Trademark Security Agreement dated as of August 19, 2016, and that certain Amendment No. 2 To Trademark Security Agreement dated as of November 7, 2016 (collectively the “**Trademark Security Agreements**”), which were recorded with the United States Patent and Trademark Office on October 28, 2014 at Reel/Frame 5389/0219, November 7, 2016 at Reel/Frame 5916/0190, and November 11, 2016 at Reel/Frame 5919/0895, respectively. The Patent Security Agreements and the Trademark Security Agreements are collectively referred to as the “**Security Agreements**” throughout this Release; and

WHEREAS, the Debtor collaterally assigned to the Lender a security interest in all of Debtor’s right, title and interest in, to and under the patents and trademarks identified in Schedule A attached hereto (the “**Intellectual Property**”); and

WHEREAS, the Lender has agreed to release its security interest in the Intellectual property and terminate such Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby states as follows:

1. Release of Security Interest. Lender hereby terminates the Security Agreements and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Debtor, and reassigns to the Debtor any and all right, title and interest that it may have, in or to the Intellectual Property.
2. Further Assurances. Lender agrees, at the Debtor’s expense, to take all further actions, and provide to the Debtor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and

all further documents or other instruments, as the Debtor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
