TRADEMARK SECURITY RELEASE AGREEMENT

This TRADEMARK SECURITY RELEASE AGREEMENT is dated as of April 30, 2018 (this "*Release*") and executed and delivered by MORGAN STANLEY SENIOR FUNDING, INC., as Collateral Agent (in such capacity, the "*Collateral Agent*") for the Secured Parties (as that term is defined in the Security Agreement among Halyard Health, Inc., as borrower, the other grantors identified therein and who from time to time become a party thereto, and the Collateral Agent, dated as of October 31, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*")), in favor of AVENT, INC., a Delaware corporation (the "*Grantor*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 27, 2015 (the "*Trademark Security Agreement*"), the Grantor granted to the Collateral Agent a security interest in and to all of the Grantor's right, title and interest in and to the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 6, 2015 at Reel 5493 Frame 0346; and

WHEREAS, the Grantor has requested and the Collateral Agent has agreed to execute and deliver this Release confirming and carrying out the release and discharge of the Collateral Agent's security interest in and to the Trademark Collateral set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent does hereby release, reassign and re-convey to the Grantor, without recourse, representation, warranty or other assurance of any kind, any and all of the Collateral Agent's security interest and all other right, title and interest in and to the Trademark Collateral identified in Schedule A attached hereto granted to it pursuant to the Security Agreement or the Trademark Security Agreement, authorizes, at the Grantor's sole cost and expense, the recordation of this Release by the Commissioner for Trademarks of the United States Patent and Trademark Office and any other applicable governmental body, and agrees to reasonably cooperate, at the Grantor's sole cost and expense, with any efforts made by the Grantor and its successors, assigns or other legal representatives to record or otherwise confirm such Release.

SECTION 2. <u>Governing Law</u>. The terms of Section 10.15 of the Credit Agreement with respect to governing law are incorporated herein by reference, *mutatis mutandis*.
