RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “**Release**”), dated as of April 5, 2018, is made by JPMORGAN CHASE BANK, N.A., in its capacity as Collateral Agent (the “**Agent**”), in favor of the Persons listed on the signature pages hereof (the “**Grantors**”).

W I T N E S S E T H:

WHEREAS, the Grantors are Guarantors with respect to the Credit Agreement, dated as of January 26, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Galleria Credit Agreement**”), among Galleria Co., the Lenders from time to time party thereto, the Agent and the other parties thereto from time to time;

WHEREAS, the Grantors and the Agent, and certain other Grantors, are parties to (i) the Pledge and Security Agreement, dated as of September 29, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and (ii) that certain Intellectual Property Security Agreement, dated as of September 29, 2016 (the “**IP Security Agreement**”), recorded with the United States Patent and Trademark Office at Reel No. 40224/0630 and Reel No. 5921/0652 and with the United States Copyright Office in Volume 9941, Doc. No. 769;

WHEREAS, pursuant to the Security Agreement and the IP Security Agreement, the Grantors assigned, pledged and granted to the Agent, its successors and assigns, on behalf of and for the benefit of the Secured Parties, a security interest in all of Grantors’ right, title or interest in and to the Intellectual Property described on Schedule I hereto and the following in respect thereof (collectively, the “**Subject Collateral**”):

- (a) (i) any and all patents and patent applications (whether issued or applied-for in the United States); (ii) all inventions and improvements described and claimed therein; (iii) all reissues, divisions, continuations, renewals, extensions, and continuations-in-part thereof; (iv) all income, royalties, damages, claims, and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages and payments for past and future infringements thereof; and (v) all rights to sue for past, present, and future infringements thereof;
- (b) all registrations and applications for registration for any of the foregoing in the United States Patent and Trademark Office, together with all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations thereof; and
- (c) all copyrights, rights and interests in such copyrights, works protectable by copyright, copyright registrations, and applications to register copyright; (b) all renewals of any of the foregoing; (c) all income, royalties, damages, and payments now or hereafter due and/or payable under any of the foregoing, including, without limitation, damages or

payments for past or future infringements for any of the foregoing; and (d) the right to sue for past, present and future infringements of any of the foregoing.

WHEREAS, the Agent now desires to terminate and release the entirety of its security interests in the Subject Collateral.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the IP Security Agreement.

SECTION 2. Termination and Release. The Agent hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its lien on and security interest in and to all right, title and interest in, to and under the Subject Collateral, including the Collateral listed on Schedule I attached hereto, and reassigns and transfers to the Grantors all right, title and interest that the Agent may have in the Subject Collateral. Notwithstanding anything herein (or in any other document, communication or filing relating hereto by any person) to the contrary, the Agent is authorizing solely the termination, release and discharge of liens on the Subject Collateral granted to it in connection with the Credit Agreements and not any other liens or security interests at any time granted by any party in favor of the Agent pursuant to any other document or in favor of any other person.

SECTION 3. Recordation. The Agent hereby authorizes the Grantors, or the Grantors' authorized representative, to record this Release with the United States Patent and Trademark Office and United States Copyright Office.



The Agent hereby agrees to duly execute and deliver to the Grantors any further documents and to do such other acts that the Grantors (or their agents or designees) reasonably request, at the Grantors' sole cost and expense, in order to confirm this Release and the Grantors' right, title and interest in the Collateral.

SECTION 5. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
