RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of April 6, 2018, (the “Effective Date”), is made by PNC Bank, National Association (as successor to National City Bank), in its capacity as collateral agent (the “Agent”), in favor of the grantor parties identified on Annex A hereto (the “Grantors”).

WHEREAS, the Grantors executed and delivered for recordal with the United States Patent and Trademark Office the intellectual property security agreements listed on Annex B hereto (together the “Trademark Security Agreements”), pursuant to which such Grantors granted to the Agent a security interest in all of such Grantors’ right and interest in and to the United States Trademark registrations and applications set forth in Schedule 1 hereto (collectively, the “Collateral”);

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office at the Reel and Frame numbers listed on Annex B hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Trademark Security Agreements.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the trademark collateral, including the Collateral, arising under the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the trademark collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantors.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

4. Further Assurances. 5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
