TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated as of June 4, 2018, is entered into by and between Sunlight Supply, Inc., a Washington corporation ("Sunlight Supply"), IP Holdings, LLC, a Washington limited liability company ("IP Holdings"), and together with Sunlight Supply, the "Company"), and HGCI, Inc., a Nevada corporation ("Assignee"), with reference to that certain Purchase Agreement, dated April 12, 2018 (the "Purchase Agreement"), by and among the Company and Hawthorne Hydroponics LLC, a Delaware limited liability company and certain other parties thereto. The Company and Assignee are each sometimes referred to herein individually as a "Party" and collectively as the "Parties." Except as otherwise defined herein, capitalized terms used in this Assignment shall have the meanings ascribed to them in the Purchase Agreement.

WHEREAS, the Company is the owner of all right, title, interest, and goodwill in and to all trademark applications and trademark registrations that are Business Intellectual Property, as defined in the Purchase Agreement (and subject to all exceptions, limitations and encumbrances identified therein), including, but not limited to, those trademark applications and trademark registrations identified in Schedule A attached herein (the "Assigned Trademarks"); and

WHEREAS, the Parties accordingly wish to execute this recordable instrument, assigning all of the Company's right, title and interest in and to the Assigned Trademarks to Assignee.

NOW, THEREFORE, for valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the Company and Assignee agree as follows:

1. The Company hereby sells, assigns and transfers to Assignee, and its lawful successors and assigns, the Company's entire right, title, and interest throughout the world in and to the Assigned Trademarks, including without limitation any and all registrations, applications, and/or common law rights for the Assigned Trademarks, together with all of the goodwill of the Company's business symbolized by or associated with the Assigned Trademarks, and any and all income, royalties, damages, and payments now or hereafter due and/or payable with respect thereto, with the right to bring actions and recover damages for any past, present, or future infringement or other violation thereof.
2. The Company hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the owner of the Assigned Trademarks, and to issue any and all Assigned Trademarks to Assignee, its successors and assigns, in accordance with the terms of this Assignment, as assignee of the Company's entire right, title and interest in, to, and under the same. Assignee shall have the right to record this Assignment with all applicable government authorities and registrars so as to perfect its ownership of the Assigned Trademarks.
3. The Company will, at the reasonable request and sole expense of Assignee, do all things reasonably necessary, proper, or advisable, including without limitation the execution, acknowledgment, and recordation of specific assignments, oaths, declarations, and other documents on a jurisdiction-by-jurisdiction basis, to assist Assignee in obtaining, perfecting,


sustaining, or enforcing the Assigned Trademarks. If Assignee is unable for any reason, after reasonable effort, to secure the Company's signature on any document in connection with the actions specified above, the Company hereby irrevocably designates and appoints Assignee and its duly authorized officers and agents as its agent and attorney in fact, which appointment is coupled with an interest, to act for and on its behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of this paragraph with the same legal force and effect as if executed by the Company.

4. Each Party agrees that governing law, venue and all legal proceedings concerning the construction, validity, enforcement and interpretation of this Assignment (whether brought against a Party to this Assignment or its respective affiliates, directors, officers, stockholders, employees or agents) will be determined in accordance with and subject to Sections 9.8 and 9.9 of the Purchase Agreement. This Assignment is executed and delivered in connection with the Purchase Agreement, and is subject to every agreement, representation, warranty, indemnity, covenant, and provision contained in the Purchase Agreement. In the event of any ambiguity, conflict, or inconsistency between the terms of this Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement, as applicable, will govern and control. This Assignment may not be supplemented, altered, or modified in any manner except by a writing signed by all Parties hereto. The failure of any Party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall bind and inure to the benefit of the respective Parties and their respective assigns, transferees and successors.
5. This Assignment may be executed in counterparts, each of which, including those received via facsimile transmission or email (including in PDF format), shall be deemed an original, and all of which shall constitute one and the same Assignment.
