#### TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 28, 2018 ("*Release*"), is made by EAST WEST BANK, a California banking corporation ("*Lender*"), in favor of SCRUBS AC, INC., a Delaware corporation ("*Grantor*").

WHEREAS, pursuant to that certain Security Agreement dated as of November 20, 2012 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and between the Grantor and Lender and the Trademark Security Agreement dated as of November 20, 2012 by and between the Grantor and Lender (the "Trademark Security Agreement"), Grantor granted to Lender a security interest in and to all of the present and future, right, title and interest of the Grantor in and to the trademarks listed in the Trademark Security Agreement, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof ("Collateral");

WHEREAS, the Trademark Security Agreement was submitted to the United States Patent and Trademark Office ("*USPTO*") and recorded November 21, 2012 in Reel 4905 at Frame 0217; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Lender.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender and Grantor agree as follows:

**SECTION 1.** <u>Defined Terms</u>. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.

#### **SECTION 2**. Termination and Release. Lender hereby

- (a) absolutely, unconditionally and irrevocably terminates the Trademark Security Agreement;
- (b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
- (c) represents and warrants that it has full authority to execute and deliver this Release; and
  - (d) authorizes the recordation of this Release with the USPTO at Grantor's expense.

Lender hereby agrees to duly execute, acknowledge, procure and deliver to Grantor at Grantor's expense any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Collateral, Lender will execute and deliver to Grantor at Grantor's expense a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
