## RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY

This Release of Security Interests in Intellectual Property is made as of the 4<sup>th</sup> day of June, 2018 (the "Release Date"), in favor of **Isagenix Worldwide, LLC**, a Delaware limited liability company, and its Affiliates identified in Schedule A (collectively, "Grantors"), by **Wells Fargo Bank, NA**, a National Banking Association ("Bank").

All of Bank's security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created in Grantors' Intellectual Property pursuant to the Security Agreements shall be automatically terminated, released and discharged.

If and to the extent that Bank has acquired any right, title or interest in or to any of the Grantors' Intellectual Property, it hereby assigns and transfers such rights, title or interest to Grantors, along with any goodwill in the Trademarks that the Bank may have acquired.
