GRANT OF SECURITY INTEREST

April 4, 2018

WHEREAS, MOHAWK FINE PAPERS, INC. and CRANE STATIONERY, LLC (herein referred to as “Debtors”) own all right, title and interest in and to certain U.S. patents and trademarks, including all rights in the patents and trademarks listed on the annexed Schedule A and Schedule B, respectively (the “Intellectual Property”);

WHEREAS, Debtors are obligated to Manufacturers and Traders Trust Company as Agent for certain Secured Parties (hereinafter referred to as “Agent”) pursuant to a Security Agreement dated as of July 1, 2013 (as the same may be amended, supplemented or otherwise modified from time to time, the “Agreement”) in favor of the Agent; and

WHEREAS, pursuant to the Agreement, Debtors granted to Agent a security interest in all right, title and interest of Debtors in and to, among other things, the Intellectual Property, including the applications and registrations therefor, together with the goodwill of the businesses connected with the use of and symbolized by the Intellectual Property and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof (the “Collateral”), to secure the payment, performance and observance of the Secured Obligations, as defined in the Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, each Debtor does hereby grant to Agent a security interest in the Collateral to secure the prompt payment, performance and observance of its obligations.

Each Debtor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral made and granted hereby are fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. Each Debtor hereby agrees that, notwithstanding anything herein to the contrary, each Debtor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with the Collateral subject to a security interest hereunder.





