## RELEASE OF TRADEMARK COLLATERAL AGREEMENT (SHORT-FORM)

This Release of Trademark Collateral Agreement (Short-Form) (this “Release”) is dated as of June 13, 2018, with reference to that certain Trademark Collateral Agreement (Short-Form), dated March 16, 2018 (the “Trademark Collateral Agreement”), made by Appvion, Inc., a Delaware corporation, (the “Borrower” and together with the Borrower and any other entity that may have become a party thereto as provided therein, the “Grantors”), in favor of Wilmington Trust, National Association, as Administrative Agent (in such capacity, the “Administrative Agent”), parties to the Senior Superpriority Senior Debtor-in-Possession Credit Agreement, dated March 16, 2018, as amended or otherwise modified prior to the date hereof. Capitalized terms used but not otherwise defined in this Release have the meanings set forth for such terms in the Guarantee and Collateral Agreement (as defined below).

WHEREAS, Grantors and the Administrative Agent are parties to the Guarantee and Collateral Agreement, dated as of March 16, 2018 (as amended or otherwise modified prior to the date hereof, (the “Guarantee and Collateral Agreement”), pursuant to which the Trademark Collateral Agreement was entered into thereby granting, pursuant to the Guarantee and Collateral Agreement and the Trademark Collateral Agreement, a security interest in, all right, title and interest of each Grantor in or to any and all of the following assets and properties now owned or at any time thereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest in, to or under the following Collateral (collectively, the “Trademark Collateral”):

(i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, in the United States Patent and Trademark Office including, without limitation, as referred to in Schedule I and (ii) the right to obtain all extensions and renewals thereof.

WHEREAS, the Trademark Collateral Agreement was recorded with the United States Patent and Trademark Office on March 20, 2018 at Reel/Frame No.: 006296/0470 and granted a security interest in the Trademark Collateral including the Trademarks listed on Schedule I;

WHEREAS, each Secured Party through the Administrative Agent desires to release and terminate the Administrative Agent’s security interest in the Trademark Collateral including the Trademarks identified on Schedule I attached hereto;

WHEREAS, the Borrower desires to record this instrument to evidence termination of the security interest in the Trademark Collateral.

NOW, THEREFORE, the Administrative Agent on behalf of each Secured Party hereby terminates, releases, and discharges fully, the security interest in and lien on the Trademark Collateral (including without limitation the Trademarks listed on Schedule I hereto) as granted pursuant to the Guarantee and Collateral Agreement and the Trademark Collateral Agreement, and any rights Administrative Agent may have in the Trademark Collateral are hereby reconveyed,


transferred, and assigned to the recorded owner, as applicable, without recourse, representation or warranty of any kind, and any right, title or interest of Administrative Agent in the Trademark Collateral shall hereby cease and become void.

The Administrative Agent hereby agrees, at the sole expense of the Borrower, to take such further actions and to execute such further documents as the Borrower may reasonably request to effect and evidence this Release, including, without limitation, the execution of any filings, statements, amendments, recordations or other instruments required to release its interests in the applications or registrations of the Trademark Collateral and record the chain of title accordingly with the United States Patent and Trademark Office.
