TRADEMARK SECURITY AGREEMENT

This Trademark Security Agreement (this “Trademark Security Agreement”), dated as of April 26, 2018, by Angels Baseball LP, a California limited partnership, (the “Pledgor”), in favor of Wells Fargo Bank, National Association (the “Bank”), for the benefit of the Bank and the other Secured Parties.

W I T N E S S E T H:

WHEREAS, the Pledgor is party to that certain Security Agreement, dated as of April 26, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) among the Pledgor, the Subsidiary Guarantors part thereto from time to time, and the Bank, for the benefit of the Bank and the other Secured Parties, pursuant to which, among other things, the Pledgor is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Pledgor hereby agrees with the Bank as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the respective meanings ascribed to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. As security for the payment or performance, as the case may be, in full of the Secured Obligations, the Pledgor hereby pledges and grants to the Bank, for the benefit of the Secured Parties, (subject, as to priority, only to MLB Liens and Permitted Prior Liens), a lien on and security interest in and to all of its right, title and interest in, to and under all the following Collateral of the Pledgor (collectively, the “Trademark Collateral”):

- (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, slogans, uniform resource locations (URL’s), domain names, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications for registration and recording filed in connection therewith, including registrations and applications for registration in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including, without limitation, those listed on Schedule 1 attached hereto (collectively, the “Trademarks”);
- (b) all reissues, continuations, extensions and renewals thereof and amendments of such Trademarks;
- (c) all goodwill associated therewith or symbolized thereby of such Trademarks;
- (d) all other assets, rights and interests that uniquely reflect or embody such goodwill of such Trademarks;
- (e) all rights and privileges corresponding to any of the foregoing throughout the world; and
- (f) all Proceeds of any and all of the foregoing.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Bank, for the benefit of the Secured Parties, pursuant to the Security Agreement, and the Pledgor hereby acknowledges and affirms that the rights and remedies of the Bank and the other Secured Parties with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Termination. Section 5.13 of the Security Agreement is hereby incorporated by reference herein as if fully set forth herein.

SECTION 5. MLB Requirements. Section 5.17 of the Security Agreement is hereby incorporated by reference herein as if fully set forth herein.

**SECTION 6. GOVERNING LAW. THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK (WITHOUT GIVING EFFECT TO THE PRINCIPLES THEREOF RELATING TO CONFLICTS OF LAW (OTHER THAN SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW (OR ANY SUCCESSOR PROVISION THERETO))).**
