RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property, dated as of April 27, 2018, is granted by Bank of America, N.A., as Agent for the Lenders under the Amended and Restated Loan Agreement referred to below, to Gibson Brands, Inc., a Delaware corporation ("Gibson").

A. Reference is made to (i) that certain Amended and Restated Loan Agreement, dated as of February 15, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), among Gibson ("Parent Borrower"), Gibson International Sales LLC, a Delaware limited liability company ("Gibson International"), Gibson Pro Audio Corp., a California corporation ("Gibson Audio"), Gibson Innovations USA, Inc., a Delaware corporation ("Gibson Innovations"), the other Borrowers from time to time party thereto (together with the Parent Borrower, Gibson International, Gibson Audio and Gibson Innovations, the "Borrowers"), the Guarantors from time to time party thereto, the lenders party thereto (collectively, "Lenders"), and Bank of America, N.A., as agent for the Lenders ("Agent"), (ii) that certain Amended and Restated Pledge and Security Agreement, dated as of February 15, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Borrowers, the Grantors from time to time party thereto, and the Agent, (iii) that certain Second Lien Intellectual Property Security Agreement, dated as of February 15, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "2017 IP Security Agreement"), among the Grantors party thereto and the Agent, and (iv) an Officer's Certificate of Gibson (the "Officer's Certificate"), a copy of which is attached as Annex A hereto. Capitalized terms used but not defined herein have the meanings assigned to such terms in the Loan Agreement.

B. Pursuant to the Officer's Certificate, and in reliance on the certifications set forth in the Officer's Certificate regarding sale of certain Specified Property by Gibson to the Purchaser (as defined in the Officer's Certificate), Agent is willing to terminate and release all security interests and liens of any kind, nature, or description, whenever and however arising, in favor of the Agent (including under the 2017 IP Security Agreement and/or the 2016 IP Security Agreement (defined below) or otherwise), in and to the following collateral: (i) the patent application identified on Schedule I attached hereto (the "Patents"), (ii) the trademarks and trademark applications identified on Schedule I attached hereto (the "Trademarks"), the copyrights identified on Schedule I attached hereto (the "Copyrights") and the other intellectual property assets identified on Schedule I attached hereto (the Patents, Trademarks, Copyrights and other intellectual property assets identified on Schedule I attached hereto including, but not limited to, software programs, virtual instruments, plug-ins, licenses, and open source libraries are hereinafter referred to as the "Released IP Collateral").

C. The 2017 IP Security Agreement (i) was recorded in the United States Patent and Trademark Office ("PTO") on February 21, 2017 at Reel/Frame 041760/0592 against the Patents, (ii) was recorded in the PTO on February 17, 2017 at Reel/Frame 5987/0001 against certain of the Trademarks and (iii) was recorded with the United States Copyright Office on February 24, 2017 against certain of the Copyrights.

D. A Second Lien Intellectual Property Security Agreement Supplement dated as of August 3, 2016 between Agent and Gibson (as amended, restated, supplemented or otherwise modified from time to time, the "2016 IP Security Agreement" and, together with the "2017 IP Security Agreement," the "IP Security Agreements") was recorded in the PTO on August 11, 2016 at Reel/Frame 005854/0242 against certain of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates its security interest and

other rights in, to and under the Released IP Collateral, together with any reissues, continuations or extensions thereof, and, with respect to any Trademark, all goodwill of the business associated with such Trademark, and including without limitation all of Agent's right, title and interest of any kind or nature in and to the Released IP Collateral under or pursuant to the IP Security Agreements.


