- (b) all rights corresponding to any of the foregoing throughout the world and the goodwill of the Borrower's business connected with the use of and symbolized by the Trademarks.

2. Lender hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by Lender, all of Lender's rights, title and interest, in and to the Trademarks.

Lender consents and agrees to execute and deliver, at the request of any successor in interest of Borrower's rights with respect to the Trademarks, such further instruments, documents, and releases as such successor in interest may reasonably request to more effectively release, terminate, and extinguish any of Lender's liens and security interest upon such Trademarks. Such successor in interest making such requests to Lender agrees to pay Lender for all out-of-pocket costs and expenses incurred by Lender in connection with the matters referred to in the previous sentence, and acknowledges that Lender's execution of and/or delivery of any further instruments, documents, and releases shall be made without recourse, representation, warranty or other assurance of any kind by Lender.
