WITNESSETH:

WHEREAS, reference is made to the Indenture, dated as of June 17, 2016 (as amended, supplemented or otherwise modified from time to time, the "<u>Indenture</u>"), among West Corporation, each of the Guarantors (as defined in the Indenture), the Collateral Agent, and U.S. Bank National Association, as trustee;

WHEREAS, the Grantors are party to an Intellectual Property Security Agreement, dated as of June 17, 2016 (as amended, supplemented or otherwise modified from time to time, the "<u>IP</u> Security Agreement"), in favor of the Collateral Agent;

WHEREAS, pursuant to the IP Security Agreement, the Grantors executed and delivered the Trademark Security Agreement, dated as of June 17, 2016 (the "<u>Trademark Security Agreement</u>") with Collateral Agent, which was recorded with the United States Patent and Trademark Office on June 17, 2016 at Reel/Frame No. 005816/0534;

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of such Grantor, mortgaged, pledged and hypothecated to the Collateral Agent for the benefit of the Secured Parties, and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A** attached hereto; and

WHEREAS, the Collateral Agent desires to terminate and release its lien on and security interest in all such Trademark Collateral and has duly authorized the execution, delivery and performance of this Trademark Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent agrees, for the benefit of the Company, as follows:

SECTION 1. <u>Definitions</u>. Unless otherwise defined herein or the context otherwise requires, terms used in this Trademark Release, including its preamble and recitals, have the meanings provided or provided by reference in the Indenture, IP Security Agreement and Trademark Security Agreement (it being understood that, in the event of any conflict between the Indenture and IP Security Agreement, such terms shall have the meanings provided or provided by reference in the Indenture and further that, in the event of any conflict between the IP Security Agreement and Trademark Security Agreement, such terms shall have the meanings provided or provided by reference in the IP Security Agreement).

SECTION 2. <u>Release of Security Interest</u>. The Collateral Agent does hereby release, relinquish, terminate and discharge its lien on and security interest in the Trademark Collateral, and hereby assigns, transfers and conveys to each Grantor, any right, title, or interest it may have in the Trademark Collateral.

SECTION 3. <u>Termination</u>. The Collateral Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

SECTION 4. Further Assurances. The Collateral Agent hereby authorizes each Grantor or each Grantor's authorized representative to (i) record this Trademark Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Trademark Collateral and/or (iii) otherwise record or file this Trademark Release in the applicable governmental office or agency. The Collateral Agent further agrees to execute and deliver to each Grantor any and all further documents and instruments, and do any and all further acts which each Grantor (or their agents or designees) reasonably request (at each Grantor's sole cost and expense) in order to confirm this Trademark Release and each Grantor's right, title and interest in, to and under the Trademark Collateral.

SECTION 5. <u>Choice of Law</u>. This Trademark Release and the rights and obligations of the parties under this Trademark Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to any principle of conflicts of law that could require the application of any other law.

SECTION 6. <u>Counterparts</u>. This Trademark Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. Delivery of an executed counterpart to this Trademark Release by facsimile or other electronic transmission shall be as effective as delivery of a manually signed original.
