TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 22, 2018 ("<u>Release</u>"), is made by GOLDMAN SACHS BANK USA, in its capacity as collateral agent for certain secured parties ("<u>Collateral Agent</u>"), in favor of PRIMO WATER CORPORATION, a Delaware corporation, PRIMO PRODUCTS, LLC, a North Carolina limited liability company, and GLACIER WATER SERVICES, INC., a Delaware corporation (each a "<u>Grantor</u>", and collectively, the "<u>Grantors</u>").

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of December 9, 2016 (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement") by and among the Grantors, Collateral Agent, and others party thereto and the Trademark Security Agreement dated as December 12, 2016 ("Trademark Security Agreement") by and among the Grantors and Collateral Agent, Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing priority security interest in, and lien upon, all of Grantors' right, title and interest in and to the Trademarks and all proceeds and products thereof (collectively, the "Trademark Collateral"); and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("<u>USPTO</u>") on December 12, 2016 at Reel 5945 Frame 0605 and a correction recorded on March 3, 2017 at Reel 6001 Frame 0379.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, on behalf of the Secured Parties, and Grantors agree as follows:

- **SECTION 1**. <u>Defined Terms</u>. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.
- **SECTION 2**. <u>Termination and Release</u>. Collateral Agent, on behalf of the Secured Parties, hereby:
 - (a) terminates the Trademark Security Agreement;
- (b) terminates, cancels, forever discharges, and releases the continuing priority security interest in, and lien upon, all of Grantors' right, title and interest in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
 - (c) represents and warrants that it has full authority to execute and deliver this Release; and
 - (d) authorizes the recordation of this Release with the USPTO at Grantors' expense.
- **SECTION 3**. Further Assurances. Collateral Agent, at Grantors' expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Collateral Agent will, at Grantors' expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
