RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "<u>Release</u>") dated as of June 28, 2018, by Credit Suisse AG, Cayman Islands Branch, as Collateral Trustee (in such capacity, the "<u>Collateral Trustee</u>") in favor of Vistra Energy Corp. ("<u>Vistra</u>"), a Delaware corporation (as successor in interest to Dynegy, Inc.).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 23, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, and including all schedules thereto, the "Security Agreement"), Dynegy Inc. (the "Grantor"), has granted to the Collateral Trustee a Security Interest in all of its right, title, and interest in the Trademark Collateral, including the trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded in the Assignment Recordation Branch of the United States Patent and Trademark Office at Reel: 5020; Frame: 0041;

WHEREAS, the Collateral Trustee terminated and released the entirety of its Security Interest in all collateral, including the Trademark Collateral, pursuant to that certain Dynegy Payoff Letter ("Payoff Letter"), dated June 14, 2018; and

WHEREAS, the Collateral Trustee now desires to confirm its termination and release of the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Collateral Trustee, for itself and on behalf of the lenders in association with the security interests, hereby agrees as follows:

- 1. <u>Defined Terms</u>. Capitalized terms used herein without definition are used as defined in the Security Agreement.
- 2. <u>Confirmation of Release</u>. The Collateral Trustee, without any recourse, representation, warranty (express or implied) or undertaking, hereby states as follows:
 - (a) The Payoff Letter terminated, released and discharged any and all of its Security Interest in the Trademark Collateral granted pursuant to the Security Agreement including without limitation, the trademarks set forth on <u>Schedule 1</u> hereto, effective as of June 14, 2018;
 - (b) any right, title or interest in and to the Trademark Collateral granted pursuant to the Security Agreement thereby ceased and became void;
 - (c) with the Payoff Letter, the Collateral Trustee waived and relinquished all of its rights, powers, privileges and remedies with respect to the Grantor, Vistra and their successors and assigns in association with such Security Interest;
 - (d) the Payoff Letter released the Grantor and their successors and assigns from all covenants, obligations, liabilities and warranties in association with such Security Interest; and
 - (e) notwithstanding the foregoing, to the extent it is deemed that the Payoff Letter did not effect such termination, release and discharge, with this document the Collateral Trustee

hereby terminates, releases and discharges any and all of its Security Interest in the Trademark Collateral.

- (f) the Collateral authorizes this Release to be recorded with the United States Patent and Trademark Office.
- 3. <u>Governing Law.</u> This Release shall be governed by and construed in accordance with the laws of the State of New York.
