**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of June 4, 2018 (this "Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as collateral agent for the benefit of Secured Parties (in such capacity, the "Agent"), in favor of Oneida Ltd., a Delaware corporation ("Oneida"), Anchor Hocking, LLC, a Delaware limited liability company ("Anchor"), Universal Tabletop, Inc., a Delaware corporation ("Parent"), Delco International, Ltd. ("Delco"), THC Systems, Inc. ("THC"), Kenwood Silver Company, Inc. ("Kenwood"), Oneida Silversmiths Inc. ("Silversmiths"), Oneida International Inc. ("International"), Buffalo China, Inc. ("Buffalo"), Oneida Food Service, Inc. ("Food Service"), Sakura, Inc. ("Sakura"), and together with Oneida, Anchor, Parent, Delco, THC, Kenwood, Silversmiths, International, Buffalo, Food Service, each a "Grantor", and collectively, "Grantors").

WITNESSETH

WHEREAS, pursuant to the Amended and Restated Trademark Security Assignment and Security Agreement, dated March 23, 2012 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on May 11, 2012 at Reel/Frame 4778/0573, the Grantors granted to the Agent a security interest in all of Grantors' right, title and interest in and to the following, whether now owned or hereafter acquired or arising (collectively, the "Released Trademark Collateral"):

(a) all of Grantors' now existing or hereafter acquired right, title and interest in and to all of Grantors' trademarks, trade names, tradestyles and service marks; all prints and labels on which said trademarks, trade names, tradestyles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature; all applications, registrations and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, any political subdivision thereof or in any other countries, and all reissues, extensions and renewals thereof including, without limitation, those trademarks, service marks, terms, designs and applications described on Exhibit A hereto (the "Trademarks");

(b) the goodwill of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; and

(c) any and all proceeds of any of the foregoing, including, without limitation, any claims by Grantors against third parties for infringement of the Trademarks or any licenses with respect thereto.

WHEREAS, Grantors have requested that the Agent release its security interest in all of the Released Trademark Collateral.

NOW, THEREFORE, the Agent, on behalf of itself, its successors, legal representatives and assigns and any lenders for which the Agent acted as security or collateral agent, without recourse, representation or warranty of any kind or nature, hereby terminates, cancels and releases its security interest in, lien upon and conditional assignments of, and hereby reassigns to the Grantors, all of the Released Trademark Collateral.

The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York.

Capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreement.

Delivery of an executed signature page to this Release by facsimile or electronic transmissions (including .pdf file) shall be effective as delivery of an original signature.
