PATENT AND TRADEMARK ASSIGNMENT AGREEMENT

This Patent and Trademark Assignment Agreement (the "Assignment") is hereby entered into on April 30, 2018 (the "Effective Date"), by and between PTG (assignment for the benefit of creditors), LLC, a Delaware limited liability company, in its sole and limited capacity as assignee for the benefit of creditors of PetEdge, Inc. ("Assignor" or "PTG"), and Ponte Pet Inc., a Delaware corporation ("Purchaser" or "Ponte").

RECITALS

A. On even date hereof, PTG and its related entities, PEDM (assignment for the benefit of creditors), LLC, PEDS (assignment for the benefit of creditors), LLC, and NR (assignment for the benefit of creditors), LLC solely in their capacities as the assignees for the benefit of creditors for the respective Assignment Estates, entered into a certain Asset Purchase Agreement ("Purchase Agreement") with Ponte in which Ponte agreed to acquire substantially all of the Assignment Estates' Assets, including, without limitation, all PTG Intellectual Property. Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Purchase Agreement.

B. Pursuant to the Purchase Agreement, PTG desires to transfer to Purchaser all of PTG's right, title and interest in and to the trademarks listed on Exhibit A attached hereto ("PTG Trademarks") and patents listed on Exhibit B attached hereto ("PTG Patents").

NOW, THEREFORE, in consideration of the foregoing and the mutual representations, warranties, covenants and agreements set forth in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, PTG and Purchaser hereby agree as follows:

1. PTG does hereby convey, assign, transfer and deliver to Purchaser, its successors and assigns (i) all of PTG's entire right, title and interest in and to the PTG Trademarks as set forth in Exhibit A to this Assignment, including the registrations and any applications for registration thereof throughout the world, together with all common law rights related thereto, and with the goodwill of the business symbolized by the PTG Trademarks, (ii) the right to sue or otherwise recover for, and the right to profits, penalties or damages due or accrued arising out of or in connection with past, present and future infringement or other violation thereof or dilution of or damage or injury to the PTG Trademarks or such represented goodwill, and (iii) all proceeds, including license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, the same to be held and enjoyed by Purchaser, its successors and assigns and their legal representatives, as fully and entirely as the same would have been held and enjoyed by PTG if this Assignment had not been made.

2. PTG does hereby convey, assign, transfer and deliver to Purchaser, its successors and assigns, all of PTG's entire right, title and interest in and to the PTG Patents as set forth on Exhibit B, together with the right to file all divisionals, continuations, continuations-in-part, reissue, reexaminations and extensions thereof, together with the right to sue for and recover all claims for damages for all infringements, including the right of recovery for past infringements thereof; the same to be held and enjoyed by Purchaser for its own use and benefit and the use and benefit of its successors and assigns and their legal representatives, as fully and entirely for the full term or terms of all such rights.

3. PTG and Purchaser agree that any filing fees associated with recording this Assignment with the U.S. Patent and Trademark Office shall be borne solely by Purchaser.

4. This Assignment has been executed and delivered by the PTG to be used for recording the Assignment herein with the appropriate government entity. At Purchaser's sole cost and expense, PTG shall execute and deliver such other documents and take all other actions which Purchaser, its successors and/or assigns may reasonably request to effect the terms of this Assignment and to perfect Purchaser's right, title and interest in and to the PTG Patents and PTG Trademarks, including, without limitation, its recordation in relevant state and national patent and trademark offices.

5. PTG hereby authorizes and requests that the U.S. Patent and Trademark Office record this Assignment.

6. Upon the consummation of this Assignment, PTG's conveyance, transfer and assignment of the PTG Patents and PTG Trademarks shall be rendered on an "AS IS" and "WHERE IS" basis, subject only to those representations and warranties expressly set forth in the Purchase Agreement. PTG represents and warrants that PTG has full and complete authority to make this Assignment.

7. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original hereof, and all of which shall constitute a single agreement effective as of the date hereof. Any delivery of an executed counterpart of this Assignment by facsimile or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.

8. This Assignment may not be supplemented, altered, or modified in any manner, except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall be binding upon and shall inure to the benefit of the parties and their respective successors and assigns.

9. This Assignment shall be governed by and construed in accordance with

federal law, to the extent applicable, and, where state law is implicated, the internal laws of the State of Delaware, without giving effect to any principles of conflicts of law.
