Reference is made to (i) that certain Credit Agreement by and among SS&C Technologies, Inc., a Delaware corporation (the "Company"), Deutsche Bank, AG New York Branch ("Assignor"), as administrative agent (the "Administrative Agent"), and the other parties named therein, dated as of July 8, 2015 (as amended by that certain First Amendment to the Credit Agreement dated as of March 2, 2017, and as further amended by that certain Second Amendment to the Credit Agreement dated as of March 9, 2018 ("Second Amendment"), and as it may be further amended, restated supplemented and/or otherwise modified from time to time, the "Credit Agreement"); (ii) that certain Security Agreement, dated as of July 8, 2015, by and among Company, Assignor, as collateral agent (the "Collateral Agent"), and the other obligors party thereto (as the same may be amended, restated, supplemented and/or otherwise modified from time to time, the "Security Agreement"); (iii) that certain Notice of Grant of Security Interest in Trademarks, dated July 8, 2015, by the Company in favor of the Collateral Agent (the "Company Grant Notice" and a "Grant Notice"); and (iv) that certain Notice of Grant of Security Interest in Trademarks, dated July 8, 2015, by Advent Software, Inc. ("Advent") in favor of the Collateral Agent (the "Advent Grant Notice" and a "Grant Notice").

WHEREAS, pursuant to the Security Agreement, the Company and Advent and the other obligors thereunder granted to the Collateral Agent for the ratable benefit of the holders of the Secured Obligations referenced therein a continuing security interest in and continuing lien upon certain collateral, including the trademark and service mark registrations and applications set forth on Schedule A attached hereto (the "Trademark Collateral");

WHEREAS, the Company Grant Notice was recorded with the United States Patent and Trademark Office on July 9, 2015 at Reel/Frame 5572/0924, and the Advent Grant Notice was recorded with the United States Patent and Trademark Office on July 9, 2015 at Reel/Frame 5572/0869 to provide notice of the Collateral Agent's security interest in the Trademark Collateral;

WHEREAS, Assignor, as resigning Administrative Agent, as resigning Collateral Agent (the "Resigning Collateral Agent") and in other capacities, and Credit Suisse AG, Cayman Islands Branch ("Credit Suisse"), as successor Administrative Agent, as successor Collateral Agent (the "Successor Collateral Agent") and in other capacities, are parties to that certain Resignation and Appointment Agreement, dated as of April 16, 2018 (the "Successor Agent Agreement"), pursuant to which Assignor, resigned as Administrative Agent and as Collateral Agent under the Loan Documents (as defined in the Credit Agreement), and the Company consented to, and Credit Suisse accepted, the appointment of Credit Suisse as the successor Administrative Agent and as successor Collateral Agent under the Credit Agreement and the other Loan Documents; and

WHEREAS, the Resigning Collateral Agent and the Successor Collateral Agent have agreed to execute this Notice to evidence the assignment of the Resigning Collateral Agent's security interest in the Trademark Collateral for recordation with the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the Resigning Collateral Agent and the Successor Collateral Agent hereby agree as follows:

The effective date of this Notice shall be April 16, 2018 (the "Effective Date").

Pursuant to the Second Amendment and the Successor Agent Agreement, as of the Effective Date, the Resigning Collateral Agent assigned to the Successor Collateral Agent all of its rights, obligations and other interests as the Collateral Agent under the Security Agreement and each Grant Notice, including the security interest granted to the Resigning Collateral Agent in the Trademark Collateral (collectively, the "Collateral Agency Interests"), and the Successor Collateral Agent assumed the Collateral Agency Interests.

From and after the Effective Date, each of the undersigned agrees (a) each reference in each Grant Notice to "Collateral Agent" is deemed to be a reference to Credit Suisse, in its capacity as Successor Collateral Agent, (b) Credit Suisse becomes vested with all of the rights, powers, privileges, duties, obligations and other interests of the Collateral Agent under the Security Agreement and each Grant Notice, and (c) Assignor is discharged from its rights, powers, privileges, duties, obligations and other interests as Collateral Agent under the Security Agreement and each Grant Notice, except to the extent otherwise expressly provided in the Second Amendment and the Successor Agent Agreement.

This Notice is to provide notice of the assignment and other matters effected pursuant to the Second Amendment and the Successor Agent Agreement, and each of the undersigned hereby acknowledges and agrees that the terms and provisions of such matters are set forth in the Second Amendment and the Successor Agent Agreement.

This Notice may be executed in any number of counterparts, each of which shall constitute an original, but such counterparts shall together constitute but one and the same instrument.
