ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (this “Assignment”), effective as of January 2, 2018 (the “Effective Date”), is by and between **Lifespan Brands LLC**, a Delaware limited liability company (“Assignor”), and **Schylling Inc.**, a Delaware corporation (“Assignee”).

WHEREAS, Assignor and Assignee entered into that certain Asset Purchase Agreement, on the date hereof (the “Purchase Agreement”), pursuant to which, among other things, Assignor agreed to assign all right, title and interest in the Purchased Intellectual Property (as defined in the Purchase Agreement).

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties hereto agree as follows:

1. Definitions. All capitalized terms used in this Assignment but not otherwise defined herein are given the meanings set forth in the Purchase Agreement.

2. Assignment.
