## RELEASE OF SECURITY INTEREST IN TRADEMARKS


KNOW ALL MEN BY THESE PRESENTS, that ISRAEL DISCOUNT BANK OF NEW YORK (“**Bank**”), DOES HEREBY CERTIFY that (x) the continuing security interest, general lien, and collateral assignment it holds in certain trademarks of PERFORMIX LLC, a Colorado limited liability company (“**Grantor**”), pursuant to the Trademark Collateral Assignment and Security Agreement, dated as of May 21, 2015, notice of which was filed with the United States Patent and Trademark Office (“**USPTO**”) on June 4, 2015 at Reel 005546, Frame 0454, as amended by Amendment 1, dated as of November 30, 2016, notice of which was filed with the USPTO on December 9, 2016 at Reel 005944, Frame 0539 (as heretofore amended, modified or supplemented, the “**Trademark Security Agreement**”), which includes the trademarks identified on Schedule A annexed hereto and made a part hereof (collectively, the “**Released Trademarks**”), and any and all other collateral relating to the Released Trademarks, including the goodwill of the business symbolized thereby, is released and discharged and all interest in such property previously assigned to Bank under the Trademark Security Agreement, including the continuing security interest, general lien and special power of attorney, is hereby terminated and reassigned to Grantor, without representation or warranty of any kind, nature or description, and (y) the Bank, without any recourse, hereby terminates and cancels the Trademark Security Agreement.


The Bank hereby authorizes Grantor or Grantor’s authorized representative to record or file this Release of Security Interest in Trademarks with the USPTO or any other applicable governmental office or agency. The Bank further agrees to execute and deliver to Grantor any and all further documents and instruments, and to do all further acts which Grantor (or its agents or designees) reasonably request (at Grantor’s sole cost and expense) to confirm this Release of Security Interest in Trademarks and Grantor’s right, title and interest in and to the Released Trademarks.

This Release of Security Interest in Trademarks shall be governed by and construed in accordance with the laws of the State of New York as applied to agreements among parties resident therein.
