**U.S. TRADEMARK AND DOMAIN NAME ASSIGNMENT**

This U.S. Trademark and Domain Name Assignment (this "Assignment") is made and entered into as of the 30th day of April 2018 (the "Effective Date"), by (a) Halyard Health, Inc., a Delaware corporation ("Parent") and (b) Avent, Inc. a Delaware corporation ("Seller" and together with Parent, a "Selling Party"), for the benefit of (c) O&M Halyard, Inc., a Virginia corporation ("Buyer Sub" and together with Parent and Seller, the "Parties").

**RECITALS**

WHEREAS, Parent, Seller, certain other subsidiaries of Parent, and Owens & Minor, Inc., a Virginia corporation and sole shareholder of Buyer Sub ("Buyer"), are parties to that certain Purchase Agreement dated as of October 31, 2017 (the "Purchase Agreement"), pursuant to which Buyer has agreed that it or its Affiliate will accept certain assets from, and assume certain liabilities of, Parent and the Sellers; and

WHEREAS, pursuant to Section 2.01(a) of the Purchase Agreement, Parent and each Asset Seller have agreed to convey, assign and transfer (or cause to be sold, conveyed, assigned and transferred) to Buyer all of the Purchased Assets;

WHEREAS, pursuant to Section 2.07(d) of the Purchase Agreement, this Assignment (which is a Bill of Sale and therefore an Ancillary Agreement) must be executed and delivered at Closing;

NOW THEREFORE, in consideration of the premises and of the mutual representations, warranties, covenants and agreements set forth herein and in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Capitalized Terms. All capitalized terms used and not otherwise defined in this Assignment shall have the meanings ascribed to them in the Purchase Agreement.

2. Assignment/Delivery of U.S. Marks. Subject to the terms and conditions of this Agreement, Seller hereby sells, conveys, assigns and transfers to Buyer Sub all of Seller's (a) worldwide right, title, and interest in and to (i) the trademark registrations and applications listed on Schedule A hereto, (ii) all rights, including unregistered and common-law rights relating to the trademarks listed on Schedule A, including in countries and jurisdictions not listed in Schedule A; and (iii) the goodwill of the business appurtenant to and/or symbolized by any of the foregoing; (collectively, the "U.S. Assigned Trademarks") and (b) right to bring an Action at law or in equity for any infringement or misappropriation of any of the foregoing before the Effective Date, and the right to retain all damages, monies and proceeds obtained in connection therewith (together with clause (a), the "U.S. Assigned Trademark Rights"), in each case, free and clear of all Encumbrances (other than Permitted Encumbrances). The Selling Parties agree to deliver to Buyer Sub all prosecution history files, legal and other documents relating to the U.S. Assigned Trademarks within 5 business days of the Effective Date.

3. Assignment/Delivery of U.S. Domain Names. Subject to the terms and conditions of this Agreement, Parent hereby sells, conveys, assigns and transfers to Buyer Sub all of Parent's (a) worldwide right, title, and interest in and to (i) the domain name registrations listed on Schedule B hereto, (ii) all rights to the domain names listed on Schedule B, including in countries and jurisdictions not listed in Schedule B; and (iii) the goodwill of the business appurtenant to and/or symbolized by any of the foregoing; (collectively, the "U.S. Assigned Domain Names") and (b) right to bring an Action at law or in equity for any infringement or misappropriation of any of the foregoing before the Effective Date, and the right to retain all damages, monies and proceeds obtained in connection therewith (together with clause (a), the "U.S. Assigned Domain Name Rights"), in each case, free and clear of all Encumbrances (other than Permitted Encumbrances). The Selling Parties agree to deliver to Buyer Sub all prosecution history files, legal and other documents relating to the U.S. Assigned Domain Names within 5 business days of the Effective Date.

4. Recordation. The Parties hereby request that all applicable Governmental Authorities, registries and registrars in all applicable countries and jurisdictions record Buyer Sub as the assignee and owner of the U.S. Assigned Trademark Rights and the U.S. Assigned Domain Name Rights.

5. Further Assurances. This Assignment is valid and effective between the Parties on a worldwide basis as of the Effective Date. The Selling Parties agree that from time to time, at the reasonable request of Buyer, the Selling Parties shall execute and deliver such other documents and take such other actions as Buyer may reasonably request to further the intents and purposes of this Assignment and to validate, effectuate, perfect and record the transactions in Sections 2-3 in all countries and jurisdictions throughout the world.

6. Purchase Agreement. Nothing in this Assignment shall be deemed to modify any of the provisions of the Purchase Agreement, all of which survive the execution and delivery of this Bill of Sale as provided and subject to the limitations set forth in the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern and control.

7. Power of Attorney. The Selling Party hereby appoints Buyer and its designees as its attorney-in-fact, which appointment is a right coupled with an interest and is deemed irrevocable, with full authority in the place and stead of the Selling Parties and in the name of the Selling Parties, if any applicable Selling Party is unable or unwilling to comply with its obligations in Section 5 after notice of such non-compliance by Buyer.

8. Notices. All notices or other communications or deliveries required to further the intents and purposes of this Assignment shall be given as agreed by the Parties.

9. Miscellaneous.

(a) Modification. This Assignment may not be amended or modified except by an instrument in writing signed by, or on behalf of, the parties hereto.

(b) Construction. The headings contained in this Assignment are for reference purposes only and shall not affect in any way the meaning or interpretation of this Assignment.

(c) Governing Law. This Assignment and all claims and causes of action (whether in contract or tort) that may be based upon, arise out of or relate to this Assignment or the negotiation, execution, termination, performance or non-performance of this Assignment and the transactions contemplated hereby (including any claims or causes of action based upon, arising out of or relating to any representation or warranty made in this Assignment) shall be governed by and construed in accordance with the Laws of the State of Delaware, regardless of the Laws that might otherwise govern under applicable principles of conflicts of Laws of the State of Delaware.

(d) Execution of Assignment. This Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original, but all of which shall constitute one and the same agreement, and any one of which may be delivered by facsimile or scanned electronic or e-mail transmission.


