TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this “**Assignment Agreement**”), effective as of February 14, 2018 (the “**Effective Date**”) is made and entered into by and among UXP Systems, Inc., a Canadian corporation, located at 1 Eglinton Ave. East, Suite 300, Toronto, Ontario M4P 3A1, Canada (“**ASSIGNOR**”), and Amdocs Development Ltd., a Cyprus limited liability company, located at 141 Omonia Avenue, The Maritime Centre, P.O. Box 50483, Limassol 3606, Cyprus (“**ASSIGNEE**”).

WHEREAS, ASSIGNOR is the owner of the registrations identified in Schedule A (the “**Trademarks**”);

WHEREAS, ASSIGNOR desires to transfer all rights, title and interest in and to the Trademarks to ASSIGNEE;

WHEREAS, ASSIGNEE desires to acquire all of ASSIGNOR’s rights, title and interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt, adequacy and legal sufficiency of which is hereby acknowledged, ASSIGNOR does hereby irrevocably sell, assign, grant and transfer to ASSIGNEE, its entire worldwide right, title and interest in and to the Trademarks, including all common law rights, along with the goodwill of the business symbolized by the Trademarks, the same to be held and enjoyed by ASSIGNEE for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this assignment had not been made, as assignee of its entire right, title and interest therein, and the right to sue, counterclaim, and recover for past, present and future infringement of the rights assigned or to be assigned under this Assignment Agreement.

This Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademarks, to record this Assignment Agreement, and to issue or transfer the said trademark records to the ASSIGNEE as owner of all right, title and interest therein, or otherwise as the ASSIGNEE may direct, in accordance with the terms of this Assignment Agreement.
