ARTICLES OF AMENDMENT
OF
ANDREWS SPACE, INC.

Pursuant to the provisions of the Washington Business Corporation Act, as amended, these Articles of Amendment to the Amended and Restated Articles of Incorporation of Andrews Space, Inc., a Washington corporation (the "*Corporation*"), are herewith submitted for filing.

1. The name of the Corporation is Andrews Space, Inc.
2. Article 1 of the Corporation's Amended and Restated Articles of Incorporation (the "*Current Articles*") is hereby amended and restated in its entirety to read as follows:
