Alan Company, an inactive Ohio corporation with an address at 555 Martin Luther King, Jr. Blvd., Youngstown, Ohio 44502 ("B.J. Alan"; Phantom I.P. and B.J. Alan, collectively, the "Borrower"). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Loan Agreement (as defined below).

WHEREAS, the Lender and B.J. Alan are parties to a Security Agreement dated as of June 5, 2015 (as supplemented by that certain (i) Joinder, by and between Phantom I.P. and Lender, dated as of December 22, 2016, (ii) Joinder, by and among Phantom Importing & Distributing, LLC, a Delaware limited liability company, Phantom Fireworks Store Sales, LLC, a Delaware limited liability company, Phantom Fireworks Western Region, LLC, a Delaware limited liability company, Phantom Fireworks Showrooms, LLC, a Delaware limited liability company, and Lender, dated as of December 30, 2016, and (iii) Joinder, by and among Phantom Fireworks, Inc., a Delaware corporation, Phantom Fireworks Company, LLC, a Delaware limited liability company, Phantom Fireworks Eastern Region, LLC, a Delaware limited liability company, and Lender), and Lender and Phantom I.P., among others, are parties to that certain Omnibus Amendment and Reaffirmation to Loan Documents dated as of January 26, 2017 (all of the foregoing, as amended, restated, reaffirmed, modified and/or supplemented from time to time, collectively, the "Security Agreement");

WHEREAS, Lender, B.J. Alan, and certain other parties entered into that certain Senior Subordinated Second Lien Loan Agreement dated as of June 5, 2015, and Lender, Phantom I.P., and certain other parties entered into that certain Amended and Restated Senior Subordinated Second Lien Loan Agreement dated as of January 26, 2017 (all of the foregoing, as amended, restated, reaffirmed, modified and/or supplemented from time to time, collectively, the "Loan Agreement")

WHEREAS, Lender and B.J. Alan are the parties to an Intellectual Property Security Agreement dated as of June 5, 2015 (the "2015 Intellectual Property Security Agreement"), and the Lender and Phantom I.P. are parties to an Intellectual Property Security Agreement dated as of January 26, 2017 (the "2017 Intellectual Property Security Agreement"; the 2015 Intellectual Property Security Agreement, and the 2017 Intellectual Property Security Agreement, collectively, the "Intellectual Property Security Agreements");

WHEREAS, pursuant to the terms of the Security Agreement, the Loan Agreement, and the Intellectual Property Security Agreements, the Borrower pledged to Lender, for the benefit of itself and the Secured Parties, a security interest (referred to in this Release as the "Security Interest") in, and mortgage on, all right, title and interest in of Borrower in and to the Intellectual

Property, including the trademarks listed on <u>Schedule A</u> hereto and incorporated by reference herein and the copyrights listed on <u>Schedule B</u> hereto and incorporated by reference herein, together with all registrations and pending applications therefor, the goodwill of the business connected with its use and symbolized thereby; and all reproduction and allied rights necessary for production, distribution and exploitation thereof, all translations, adaptations and other versions thereof now made or thereafter created and all proceeds thereof, including, without limitation, any and all causes of action for infringement for the full term of the Intellectual Property, if applicable, and any and all royalties for the licenses thereof (the "<u>IP Collateral</u>"); and

WHEREAS, B.J. Alan assigned all of its rights in and to the IP Collateral to Phantom I.P.; and

WHEREAS, the Secured Obligations have been paid and performed in full and the Lender has agreed to terminate and release on behalf of itself and the other Secured Parties all of its right, title and interest in or to the IP Collateral, including the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

- 1. Release of Lien. The Lender, on behalf of itself and the Secured Parties, hereby (i) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges the Security Interest and any of its and the Secured Parties' right, title and interest in or to the IP Collateral, whether granted pursuant to the Intellectual Property Security Agreements or the Security Agreement, (ii) terminates the Intellectual Property Security Agreements, and (iii) reassigns, without any representation or warranty of any kind whatsoever, to the Borrower any and all right, title and interest (if any) that the Lender may have held on behalf of itself or any other Secured Parties under the Intellectual Property Security Agreements in or to any of the IP Collateral, including any goodwill associated therewith, all such rights to sue or to recover, at law or in equity, for any past, present or future infringement, dilution, misappropriation or other violation of the IP Collateral and all such rights to any income, royalties, and proceeds arising from or with respect thereto.
- 2. <u>Authorization to Record</u>. The Lender authorizes and requests that the United States Patent and Trademark Office (the "<u>USPTO</u>"), the U.S. Copyright Office (the "<u>Copyright Office</u>") and any applicable government office record this Release. This Release may, in particular, be recorded with the USPTO to reflect the release of the 2015 Intellectual Property Security Agreement recorded with the USPTO on June 9, 2015, at Reel/Frame 5548/0448 and the release of the 2017 Intellectual Property Security Agreement recorded with the USPTO on March 7, 2017, at Reel/Frame 6002/0511. This Release may also be recorded with the Copyright Office to reflect the release of the 2015 Intellectual Property Security Agreement recorded with the Copyright Office as of June 11, 2015, as V9938 D400, and the release of the 2017 Intellectual Property Security Agreement recorded with the Copyright Office as of February 2, 2017, as V9942 D605.
- 3. <u>Further Assurances</u>. The Lender agrees to cooperate with Borrower and to provide the Borrower with such information and additional authorization and to execute and deliver to

Borrower such additional instruments and to take such action, in each case, as the Borrower may reasonably request or as may be desirable to effect and record the release of the Security Interest, and Borrower shall pay or promptly reimburse Lender for all costs and expenses (including out-of-pocket attorney's fees) incurred in connection therewith.
